
Dear Ms. Askerneese:

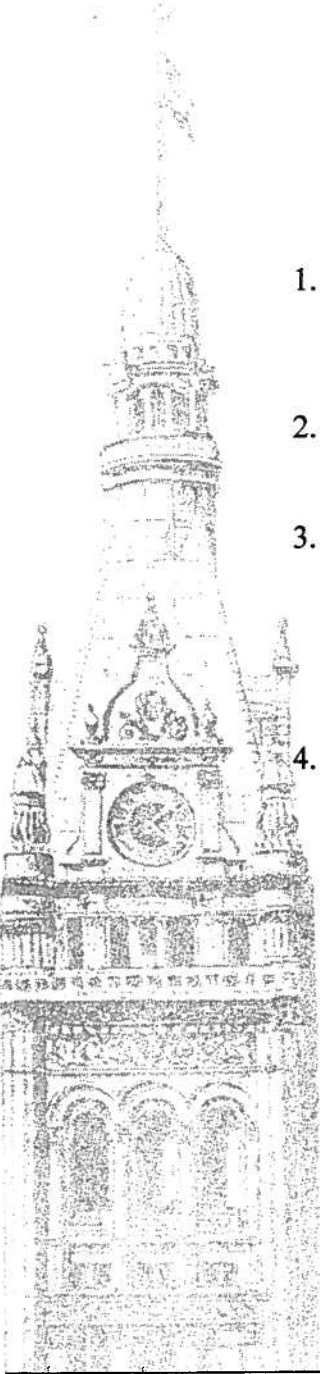

Re: Report on the Renewal Application of the Class "D"
Bartender License of Paris M. Askerneese

FINDINGS OF FACT

1. Paris M. Askerneese (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2009.
2. An application to renew said license was untimely filed with the Office of the City Clerk on December 30, 2009.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On December 31, 2009, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On January 26, 2010, this licensee was before the Committee and the Licensee's Class "D" Bartender license was granted contingent upon the licensee providing proof of arrangements to pay or proof of full payment of the outstanding balance of Milwaukee Municipal Court fines on or before the close of business Friday, February 5, 2010. She did not. On February 9, 2010, the City Clerk's Office again provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on February 17, 2010, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear and she was not represented by counsel.



5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Paris M. Askerneese at 1725 North Prospect Avenue, Milwaukee, Wisconsin 53202 on February 4, 2010 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 1725 North Prospect Avenue, Milwaukee, Wisconsin 53202 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on February 17, 2010.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Paris M. Askerneese, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Paris M. Askerneese based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "D" Bartender license be denied based upon nonappearance.

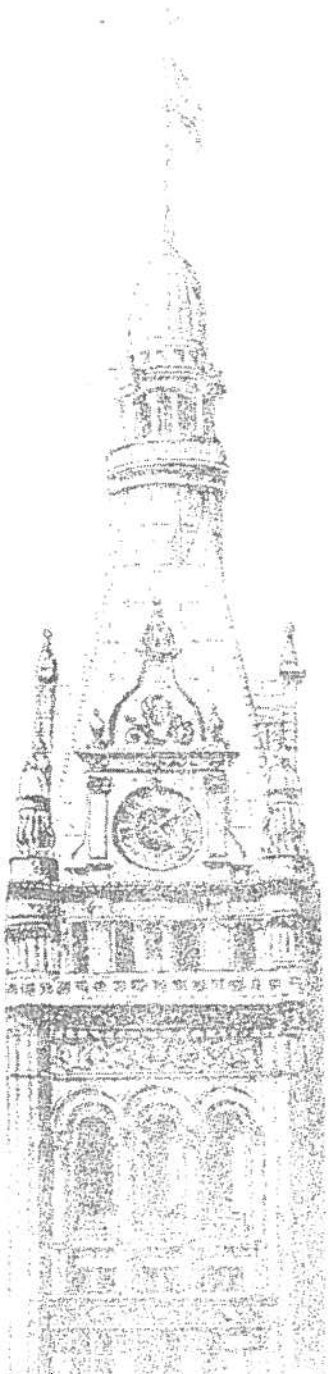

FINDINGS OF FACT

1. Rochelle A. Hill (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2009.
2. An application to renew said license was untimely filed with the Office of the City Clerk on November 16, 2009.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 18, 2009, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On February 4, 2010, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on February 17, 2010, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee did not appear and she was not represented by counsel. That was the applicant's second nonappearance.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:



- A. A notice of the hearing as well as a copy of the police report was sent to Rochelle A. Hill at P.O. Box 12201, Milwaukee, Wisconsin 53212 on February 4, 2010 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of P.O. Box 12201, Milwaukee, Wisconsin 53212 is the address given by the Licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on February 17, 2010.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Rochelle A. Hill, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Rochelle A. Hill based upon nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) noes and one (1) excused, recommends that the Class "D" Bartender License be denied based upon nonappearance.

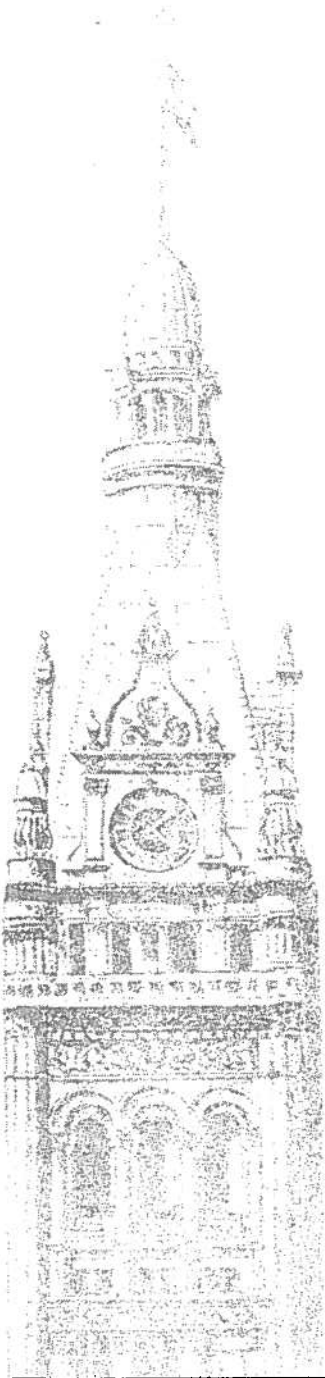

Re: Report of the Renewal Application of Enrique Terrones for a Class "B" Tavern and new Tavern Dance application for the premises located at 1631 West Grant Street, in the City and County of Milwaukee, Wisconsin ("Primos Place").

FINDINGS OF FACT

1. Enrique Terrones (hereinafter the "Licensee") is the holder of a Class "B" Tavern license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, March 7, 2010.
2. An application to renew said license was filed with the Office of the City Clerk on January 19, 2010.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated January 20, 2010, which could form the basis for non-renewal or suspension of the license. There were also claimed neighborhood objections to loitering, littering, loud music and noise, parking and traffic problems, drug and criminal activity, prostitution, trespassing, public urination, fights, shootings, vandalism, thefts, and operation of the premises in such a manner that it creates a public nuisance and conduct which is detrimental to the health, safety and welfare of the neighborhood.
4. On February 4, 2010, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of a police report along with a copy of that report that could form the basis for suspension or non-renewal of the license of the Licensee and neighborhood objections. The matter was scheduled for a



hearing on the police report and neighborhood objections on February 17, 2010 at 8:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the notice and police report. He was represented by Attorney Michael Knoeller, 610 West Lincoln Avenue, Milwaukee, Wisconsin 53215.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On September 20, 2008 at 1:11 a.m., officers of the Milwaukee Police Department were dispatched to 1619 West Grant Street for a battery complaint. The investigation revealed that a patron of Primos exited the tavern to make a phone call on his cell phone when several unknown males who were across the street came over and began hitting him. These subjects removed the victim's wallet from his pants and fled the scene. The victim reported minor injuries. An incident report was filed.
 - B. On January 9, 2009 at 6:45 p.m., officers of the Milwaukee Police Department conducted a license premise check at 1631 West Grant Street. Officers spoke to the licensee, Enrique Terrones, and asked Mr. Terrones for receipts and invoices regarding his purchase of liquor. Mr. Terrones could not provide any invoices or receipts and officers confiscated the liquor and provided Mr. Terrones with a property receipt. No other violations were found. At hearing the licensee, through his counsel, stated that he could not find the receipts in question and voluntarily turned the liquor over.
 - C. On June 21, 2009 at 9:53 p.m., officers of the Milwaukee Police Department were dispatched to 1631 West Grant Street for an armed robbery complaint. The investigation found that an unknown male entered the tavern armed with a gun and demanded money from the bartender. When money was not obtained, the suspect pointed his gun at a patron, obtained her purse and fled the tavern. The bartender chased and caught the suspect and detained him until police arrived. No injuries were reported. An objecting neighbor testified that the robbers spilled into an alley behind her home and one of the patrons grabbed the gun and waved it. The licensee testified that the bartender was off duty and was present as a customer. Nonetheless, he did chase down the robber.

- D. There were also neighborhood objections to noise, litter, and the condition and cleanliness of the building. The neighbors revealed that there is a window held together with masking tape. The licensee revealed that the window has been in that condition for five months. One neighbor testified to patrons using her back yard for sexual activity and her having to pick up used condoms.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee, Enrique Terrones, for the licensed premises at 1631 West Grant Street, Milwaukee, Wisconsin ("Primos Place ") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern license without undergoing a ten (10) day suspension of said license. The Committee finds the police report and neighborhood objections, as stated above, to be true.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to renew the Class "B" Tavern license of Enrique Terrones for the premises at 1631 West Grant Street in the City and County of Milwaukee, Wisconsin ("Primos Place") with a ten (10) day suspension, and to condition its recommendation for renewal on a requirement that the window be properly repaired before March 1, 2010.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of two (2) ayes, one (1) no, one (1) excused, and one (1) absent, recommends that the Class "B" Tavern license of Enrique Terrones for the premises located at 1631 West Grant Street in the City and County of Milwaukee, Wisconsin ("Primos Place") be renewed with a ten (10) day

suspension, and that the licensee make proper repairs to the building before March 1, 2010.

Said suspension is to be in effect from 12:01 a.m., March 8, 2010 through midnight March 17, 2010.
