You were further notified that the Milwaukee Common Council would consider the matter at its meeting of November 15, 2005 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of your right to file written objections or to appear personally or by counsel to address the Common Council. At that date, time and place you did appear; however, you did not file written objections to the report of the Licenses Committee. You requested an opportunity to withdraw your application for renewal. Because of § 90-11-3 of the Milwaukee Code of Ordinances, the matter was returned to the Licenses Committee for consideration of this request.

Following consideration of the report of the Licenses Committee and your request to withdraw your application, the Common Council remanded this matter to the Licenses Committee by a vote of fifteen (15) Ayes and zero (0) Nays.
