Failure of the applicant to meet the statutory and municipal license qualifications. Pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed activity, on behalf of the licensee, his or her employes, or patrons, other than those specified in s. 218.0116, Wis. Stats., as amended. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. ### LICENSED PREMISE REPORT

This report is typed by Frank HEEG, District 6, assigned to Late-Power on Squad# 6480, in full duty uniform, equipped with Axon Body 3 Camera, operating fully marked, fully functional, Milwaukee Police Department Squad# 65621.

On Saturday, August 9, 2025, I took a theft report, at the address of 5848 S. 27th St., Cream City Auto, which is located in the City and County of Milwaukee, State of Wisconsin.

Upon arrival I spoke with Khamis H. ASSAD (w/m, 01/28/99), who is the person in charge of the Dealership, who provided me with a paper copy of a Wisconsin Driver's License, and stated that he allowed this subject to test drive his 2015 Chevrolet Suburban (VIN# 1GNSKJKC9FR645578) and he has not returned it. The WI license belonged to Melvin V WILLIAMS (b/m, 10/21/79). ASSAD stated that he had allowed him to test drive a vehicle on Friday, August 8, 2025, and after a few hours he returned that one, so he did not think that this was a big deal, until an hour of it being gone.

ASSAD stated that he does not have any contact information for WILLIAMS and did not give him a specific time frame to have the vehicle back. It is to be noted that he permanently affixed the dealer plate MV5666J to the rear of the Suburban, prior to the test drive. ASSAD did have cameras but due to weather we were unable to look at them. ASSAD was cooperative during the investigation and understands the procedure.

There is no title in the vehicle, and the only set of keys went with the vehicle. He stated that he did give the vehicle voluntarily and has no way of contacting WILLIAMS to ask for the vehicle back.

At the time of this report I did ask for additional resources to check the DOT of WILLIAMS and they have not gotten back to me regarding.

There were no violations observed at the time of this report.

## **Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:**

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.  
**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**
