William can be very responsible, but with the recent street takeovers we need strict compliance with parking and hangout.

The only way for safety and for residents is to keep these cars moving. If William is committed he will continue to adhere to our conditions listed above. This is a school zone, school bus drop off area and we intend to develop a safety net for our residents, students and those who need to have service and city bus stops safe.
