RE: FILING OF LIABILITY CLAIM

Greetings,

On 07/03/2018, Mary Gleason tripped and fell over uneven sidewalk in front of 2968 N 9th St, Milwaukee, WI. Ms. Gleason fell, sustaining a broken nose as well as lacerations and abrasions to her knees, shoulder and ankles. She also claims to be suffering from headaches which have started since the accident.

Ms. Gleason was in the course of her employment at the time of her fall. As the Workers Compensation insurer for her employer, Society Insurance has opened a workers compensation claim file for Ms. Gleason.

Per Wis. State Statute 102.29, Society Insurance in this case, has the same right as Ms. Gleason to present a claim against a third party, whose negligence is the proximate cause of the injuries sustained.

As a rightful claimant in this matter per Wis 102.29, it is our position that the City of Milwaukee is negligent in their failure to properly maintain their property, allowing an unsafe, dangerous and hazardous condition to exist and that the City of Milwaukee is then liable for the damages sustained.

This letter then

- 1) Puts the city on notice of the claim within the 120 day time limit.
2) Describes the circumstances of the claim as above.
3) Provides the address and phone number of Society Insurance as below.
4) And makes claim for relief in the amount of \$10,000*.

* Note that this is a recent accident and the full nature and extent of damages is not yet fully realized. The amount claimed is our best estimate of the workers compensation benefits to be paid and is subject to change. Also note that this does not include any claim for Ms. Gleason's pain and suffering and that such a claim may be added hereto at a future time. If Ms. Gleason does not make such a claim herself, Supreme court case Threshermen's Mutual v. Robert Page (95-2942) allows for Society to make that additional claim.
