Dear Ms. Gregory:

We have received your claim in the amount of \$1,982.76, relating to personal property that was allegedly damaged on December 12, 2007 due to a water main break near your property located at 2465 North 22nd Street.

Our investigation reveals the Milwaukee Water Works (MWW) received a report of a leak on the date in question and arrived at West Wright Street, between North 21st Street and North 23rd Street, the scene of the leak shortly thereafter. The dispatched MWW investigator confirmed there was a possible break in a 30inch water main. The main was shut off. Due to the scope of the damages the decision was made to clean up and secure area. A private contractor was then hired to make the extensive repairs to the MWW facilities that were damaged. The MWW responded to the water main break in a timely manner and followed standard procedures regarding the repair activities. Therefore, we are denying your claim.
