This report is written by PO Richard HOFFMAN, assigned to Squad 7281, District Seven, Anti-Gang Unit, Early Shift.

On Tuesday, September 22, 2009 at 10:15PM, PO James SOMMER and I were on patrol in a marked squad. As PO SOMMER and I exited the "T" alley just east of N. 78th St., he and I observed a blue, Ford Econoline van, license #420-PBC, parked in a patch of darkness just south of 3463 of N. 78th St. The van was parked, with the side, "opera" windows flipped open, but with the remaining windows closed, and steamed up from the inside. As PO SOMMER and I observed the van, PO SOMMER ran the license plate, which was revealed to be unregistered. At that time, PO SOMMER drove closer to the van so he and I could observe it further.

PO SOMMER stated he believed he observed someone inside of the van, and in turn, he stopped the squad and stepped out of the squad. I then began shining my flashlight through the front, driver's side window, and into the passenger compartment. I did not initially see anyone, but I heard a sudden noise from inside of the van. The noise suggested that someone was inside of the van, and had made a sudden movement in response to my flashlight. At that time, I circled to the rear of the van, and could see the silhouette of someone inside.

As I stood on the driver's side of the van, PO SOMMER went to the passenger side, sliding door. The person PO SOMMER and I saw inside, Randolph E. ROSS (B/M, 7-19-84, 2200 N. Martin Luther King Dr., #B33,

263-5043), unlocked the sliding door, and PO SOMMER then opened it. Once the door was opened, PO SOMMER could see that ROSS was sitting on the van's middle seat. He was unclothed except for the shirt he was holding over his genital area. PO SOMMER could also see [REDACTED] I. [REDACTED] [REDACTED] [REDACTED], who was sitting on the seat behind ROSS. [REDACTED] was covering herself, and was unclothed except for a pair of underwear. At that time, PO SOMMER and I had [REDACTED] and ROSS clothe themselves, and had each one step out of the van in turn.

I had ROSS step out of the van and had him sit in the back of the squad car. After that, I had [REDACTED] step out. At that time, I asked [REDACTED] how old she was, and she stated she was "16." She then stated ROSS was "25." I asked how long she and ROSS had been "together," to which she stated, "three months." I then asked her if she and ROSS were using a condom, and she replied, "Of course." I also asked her if she and ROSS have had sexual intercourse in the past, and she stated, "Yes."

After that, I went over to ROSS, and asked how long he had been dating [REDACTED]. He stated, "For like a month." I then asked ROSS if "today" was the first time they had sex. He replied, "Yeah."

After speaking with ROSS, I contacted the District Seven Acting Lt., Sgt. Riestra, who contacted the Sensitive Crimes Division, and in turn informed me I was to handle the investigation.

As I was speaking with Sgt. Riestra, PO SOMMER informed me he had interviewed [REDACTED] mother, [REDACTED] [REDACTED] ( [REDACTED] [REDACTED] ). [REDACTED] stated she was aware of [REDACTED] boyfriend, ROSS, as well as his age. [REDACTED] further stated she was aware that [REDACTED] and ROSS were having sexual intercourse, and was accepting of the situation.

PO SOMMER then interviewed [REDACTED], who stated she had known ROSS for three to four months, and had sexual intercourse with him four to five times. She stated they have always used a condom. She further stated she met ROSS through a friend, and only knows him as "J." She stated she knows he is older than 18, but doesn't know how old exactly. [REDACTED] also stated she and ROSS go out to dinner one to two times a week, and only considers him to be a friend.

Shortly after, I then handcuffed ROSS and took him into custody. In response to that, [REDACTED] began to state it was "bullshit," and that she was angry that PO SOMMER and I were arresting her boyfriend. She also stated she intended to testify on his behalf.

ROSS was conveyed to District Seven for booking, and [REDACTED] was conveyed to her home by other officers.
