

Ordinance relating to the change in Ordinance relating to the change in Zoning from Local Business to Detailed Planned Development on land located on the North Side of West Windloke Avenue and East of South 13th Street, in the 12th Aldermanic District.

Section 295-907(2kc).0122.

(1) In occordance with the provisions of Section 295-907 of the Code relating to the establishment of planned development districts, the Common Council opproves the subject Detailed Planned Development, o copy of which is attached to this Common Cauncil File os Exhibit A wh h is on file in the office

of the City Clerk and made a part as though fully set torth herein.

(2) The zoning map is amended to change the zoning for the area described and bounded by the zoning line within West Windlake Avenue, the controlline within South 13th Street, a line 276 feet South ond parollel to the south line of West Becher Street, and the northeast line of the property at 1220 West Windlake Avenue extended, from Local Business (B2) to Detailed Planned Development (DPD).

(3) The requirements set forth in said detailed plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the effect of the opproval of such detailed plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the detailed plan is such detailed plan.

Part 2. Any persons, firm, company or corporation awning, controlling, or monaging any building or premises wherein or whereon there shall be placed or there exists anything in violation of the terms of this ordinance; or who shall build contrary to the plans ar specifications submitted to and opparation of City Development, or any
