This office is in receipt of your claim alleging your personal property was removed from the vehicle when it was towed to the City tow lot on February 20, 2003.

Our investigation reveals that your vehicle was towed on February 20, 2003 for being illegally parked. The PT-27 form filled out prior to the tow, indicates that the vehicle was locked and contained a radio. The Vehicle Inventory Form confirms this. The Tow Lot Intake Video shows a detached radio face plate; no CD's or DVD's were noted. The vehicle was locked until you brought the keys and the vehicle was released to you. Since there is no specific evidence to support your belief that the tow lot stole the items from your vehicle, the City cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeals this decision, you may do so by sending a letter with within 21days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
