This report is written by Police Officer Carls Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 02/16/21 officers were dispatched to Walgreen's at 6292 S. 27th St., for a Theft. The officers spoke with an employee who stated a subject pried open the cash register located behind the photo counter and fled with \$58.75. The business was cooperative with allowing the officer to view the video surveillance.

The officers spoke to the employee who stated he overheard a subject talking on the phone regarding a shoplifting offense that took place at a separate location. Upon arrival, I spoke to an employee who was later identified as Thomas J. SAMUEL (W/M 11/26/2002). SAMUEL stated that a known actor who was later identified as Elijah J TRICE (B/M 10/31/2004) intentionally and without consent pointed and aimed a black in color handgun at himself, causing him to fear for his safety on the date of June 6th, 2025.

On June 11th, 2025, I spoke to the manager who was a witness on scene for the incident that occurred

on June 6th, 2025. On scene, the manager was identified as Victoria E. HARTUNG (W/F 06/25/1991).

The business was cooperative with officers' investigation. The business had 0 security officers on scene. I reviewed video surveillance footage that depicted at approximately 6:23 PM on June 6th, 2025, a Black Male wearing an Orange Jacket with white stripes on each arm, light blue jeans, black backpack, tan hat, and white and black shoes exit the location and walks Southbound in the parking lot. On video, it appears TRICE is speaking to SAMUEL who is located at the entrance of the location. TRICE is observed on video to display a black in color firearm, pointing and aiming it twice at SAMUEL just before he leaves the scene on foot at approximately 6:25 PM.

While on scene, I observed the licenses posted and they were up to date. During my investigation for Recklessly Endangering Safety, I did not observe any violations in the licensed premise.
