Dear Mr. Boutell:

We have received your claim in the amount of \$2,807.72, relating to damages to your vehicle on January 13, 2009 that were allegedly caused by a City of Milwaukee plow vehicle at or near North 56<sup>th</sup> Street and West Wisconsin Avenue.

Our investigation reveals that the Fleet Accident Report completed as a result of this incident noted that you were unable to provide any identification numbers and only had a vague description of the truck. The report also noted this route is used by plow trucks owned by the City of Wauwatosa and Milwaukee County and other privately owned trucks. The Support Services investigator also noted the damage is inconsistent with the damage that would be caused by a City snow plow truck. Since you are unable to provide a truck number and there is no other proof to support your belief the City caused your loss, it cannot accept liability and we are denying your claim.


