passed away on May 23, 2016 at the age of 85, and funeral services were held on May 28, 2016 at St. John the Baptist Church in Plymouth; and

WHEREAS, *Ervin Golembiewski was born on May 5, 1931 in Milwaukee to parents John and Helen Golembiewski, attended St. Hyacinth Grade School in Milwaukee and graduated from Boy's Trade and Technical High School in 1949, and attended the University of Wisconsin-Madison, graduating in 1953 with a bachelor's degree in Accounting; and*

WHEREAS, *Ervin Golembiewski married Patricia Piotrowski on June 9, 1956, who preceded him in death on February 28, 1986, and later married Linda Phelps at St. Marcus Lutheran Church in Milwaukee on November 25, 1989; and*

WHEREAS, *Ervin Golembiewski worked for the City of Milwaukee for more than 32 years as Director of the Department of City Development and later as Deputy City Treasurer before his retirement in 1996; and*

WHEREAS, *Ervin Golembiewski was an original member of the board of the Polish Festivals Committee, raising funds and purchasing the land necessary to build the Polish Center in Milwaukee, served as President of the St. Vincent de Paul Society in Plymouth, which expanded six times during his tenure of oversight, and served on the Board of the Plymouth Education Foundation, donating to and becoming actively involved in the capital campaign for the Food Science and Agriculture Center at Plymouth High School; and*

WHEREAS, *Ervin Golembiewski leaves to cherish his memory his wife of 26 years, Linda, his beloved children Mark and Gail, loving grandchildren Emily, Megan, Clare, Peter, Michael, Patricia, Andrew and Sam, as well as a host of other loving family and friends; now, therefore, be it*
