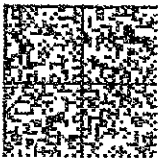

On April 10th 2015 at approximately 10:30pm I was traveling Northbound on 92nd street, at about 92nd and Marion I hit a huge road defect that caused considerable damage to my motorcycle front and rear rims, tires, lower and front fork fairing. I am an experienced rider and managed to keep the motorcycle upright and make it to the median without "dropping" the motorcycle. The street lights in this area were out also making it extremely difficult to see this hazard. I have enclosed the estimate of repair for my motorcycle as well as pictures and a video of the area on a thumb drive (returning the thumb drive not needed). The overall size and age of this defect illustrate that it has been there for some time. After speaking with my attorney, I was made aware that copy of this claim must be made available to the city prior to any legal pursuit. Although my back was injured in this unfortunate incident I seek only to have my motorcycle repair as quickly as possible to put this event behind me and not have it dragged out in a court room. I thank you for your time and look forward to an amicable response.
