Dear Ms. Lang:


This office is in receipt of your claim in the amount of \$1,574.26, relating to your subrogation interest and the interest of your insured arising from damages to your insured's vehicle on December 29, 2000 when it was allegedly struck by a City snowplow at 3154 North Achilles Street.

The Fleet Accident Report completed as a result of this alleged incident indicates that the City nor any of its plow contractors had a white snowplow truck out on the date in question. Since no City driver has reported colliding with your insured's vehicle, and she is unable to provide any information with respect to a truck or license plate number, we are unable to verify a City snowplow was involved. As such, the City cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
