Our traffic engineering staff has investigated this request and found that motorists exiting the underground parking garage at this address have a difficult time seeing traffic traveling northbound on North Van Buren Street when vehicles park close to their driveway. Therefore, in the interest of public safety, we recommend installing this restriction to increase visibility at the driveway.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
