As you know, the above matter is before the Economic Development Committee at 1:30 p.m today and in connection therewith, the applicant, Air Wisconsin Airlines Corporation ("Air Wisconsin") has reviewed the Authorizing and Approval Resolution and the Project Narrative attached thereto.

So that there is a clear pictures presented as to the extent of Air Wisconsin's operation, I would ask that paragraph 3 under I. PROJECT, be revised as follows:

"Air Wisconsin, headquartered in Appleton, is one of the nation's largest regional airlines. Flying both as United Express and Air Tran Jet Connect, it serves 62 cities in 26 states, including the United Airlines' hubs at O'Hare International Airport in Chicago, and Denver International Airport and Air Tran Airlines' hub at Hartsfield International Airport in Atlanta. Air Wisconsin also serves the Canadian market with service from the United States to Winnipeg, Manitoba and Edmonton, Alberta, Canada."

Rather than amending the Project Narrative, I request that you introduce this communication and request that the Committee accept it and make it a part of the file.

I am taking the liberty of forwarding copies of this item to Chairman Hines and all members of the Committee in advance of this afternoon's meeting.


