On Wednesday, November 15, 2023, at 12:30 pm, my partner PO Michael Ward and I met with licensee/agent Paphitchaya Liotrakun and her business partner Sarawut Pronpromtada. The business is located on the west end of a multi-rental business property.

The interior of the business is equipped with 4 surveillance cameras, which one located in the front faces the entrance and exit door. There is also a camera located in a common hall way with connects with the business to the east. The rear door of the business, which leads to the common hallway can be locked and secured. There is 2 exterior cameras located to the west of the property one faces the parking lot and the other camera faces the patio area. There will be an additional 6 cameras throughout the exterior of the building. Video is stored for approximately 3 weeks.

The business does have exterior lighting but more lighting will be added throughout. A discussion was had regarding "No Loitering" signs and the standing complainant form. No security will be added.




City Concentration Map for 2159 S Kinnickinnic Av




