Please find and consider the enclosed Petitions "To make permanent the change to Chapter 100-52 sec 3(a-1) of the City of Milwaukee Ordinances". These petitions have been signed by approximately 185 PPL holders who drive taxicabs in the City.

While the cost of fuel has been going down from the record levels that we have all been paying since last spring, gasoline is still over \$2.00 per gallon and does not seem to be going back to the prices of 2005. Meanwhile, the cost of other goods and services needed by these drivers and their families has been steadily rising over the last 6 months. Food, heat, housing and clothing are necessities and this is what the fares collected by the drivers for their services goes to provide for their families.

Please have the committee consider these petitioners at the upcoming meeting of the Public Safety Committee on October 5, 2006. I will be attending this meeting and stand ready to discuss this subject and answer any questions that the committee members may have.
