1st Aldermanic District

Alley between W. Florist Ave., W. Oriole Dr., N. 34th St., N. 35th St. (ST212220105)
Concrete alley pavement reconstruction, and grading.

5th Aldermanic District

W. Glendale Ave. – N. 84th St. to N. 87th St. (ST211210198) Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8.0'width of tree border area) and grading.

7th Aldermanic District

Alley between W. Glendale Ave., W. Ruby Ave., N. 41st St., N. 42nd St. (ST212220103) Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, storm drainage facilities, and permeable pavement as necessary.

11th Aldermanic District

S. 48th St. – W. Forest Home Ave. to W. Oklahoma Ave. (ST211180218) Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (11.0'width of tree border area) and grading.

S. 94th St. – W. Howard Ave. to a point 600' North of W. Howard Ave. (ST211150111) Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8.0'width of tree border area) and grading.

13th Aldermanic District


S. 5th St. – W. Howard Ave. to S. 5th Pl. (including W. Morgan Pl.) (ST211210202)

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8.0'width of tree border area) and grading.
