The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 04/12/2021 at 1:20pm officers conducted a license premise check at Sentry Foods, 9210 W. Lisbon Av. The officers observed the liquor department gate was open and beer was displayed for sale. The officers spoke with Timothy HOGAN, who stated he is the current agent of the business and would remain with the business until the business was sold to the new owner on 04/18/2021. The officers advised the applicant the new liquor license has not been issued yet and they could not sell alcohol until the new license was issued. The applicant stated he would not sell alcohol until the license was granted.
- 2. On 08/01/2021 at 6:00pm an officer investigated a Trouble with Subject at Sentry 9200 W. Lisbon Av. The officer spoke with the caller by phone. The caller stated he was at the Sentry at 9200 W. Lisbon Av. and was disturbed the security officers were open carrying firearms. The caller admitted he was also open carrying a firearm and felt harassed by security. He stated no threats were made. The caller was advised both parties likely felt uncomfortable due to the other party open carrying.

This report is being submitted by PO Xavier Benitez assigned to The License Investigation Unit.

On Monday April 12th, 2021 at 1:20pm PO Penny Monreal I conducted a license premise check at 9210 W. Lisbon Ave, Sentry Foods. At the time of the license premise check I was equipped with an axon body worn camera, for the interaction in its entirely review camera footage.

Upon arrival officers walked past the liquor section of the food store, which is located in the front area of the store. The alcohol section has a gate type style door which can be closed after sale hours, the gate was observed open. Some beer was in a fridge separate, near the liquor display. Officers briefly spoke with the manager on duty, who directed officers to the current owner/ agent of the business, Timothy A. Hogan. Officers then spoke Mr. Hogan, who stated that he is still technically the owner till Sunday April 18th, 2021, that is when the new owner/agent, Bharat NMN Bansal will take over owner ship.

Officers advised Mr. Hogan that the new Liquor License for the business has not yet been approved yet by the City of Milwaukee, and that liquor/beer should not be sold till the approval. Mr. Hogan stated that he will have the liquor/beer merchandise locked up and notify the new owner regarding. Officers advised Mr. Hogan that officers will also contact the new agent/owner regarding the license issue.

At the time of the interaction with Mr. Hogan no liquor/beer sales was observed.

PO Monreal made contact with Mr. Bansal via telephone and advised him the Liquor License is still pending approval. Mr. Bransal stated that he was aware of the issue and will not sell the merchandise till the license is granted, and that he would contact the alderman's office regarding.

Milwaukee. During this time, I attempted to handle calls that did not seem criminal in nature over the phone, due to the amount of backlog of calls pending in District 7.

I called the caller of a Trouble with Subject complaint, that occurred at the address of 9200 W Lisbon Ave, which is a Sentry Foods, located in the City and County of Milwaukee.

I called the caller Nicholas J MCVEY (W/M 7-12-1984) at the provided phone number of (414)484-6411.

MCVEY stated that on August 1st, 2021, he found it disturbing that the security guards at Sentry were open carrying firearms. MCVEY stated that he felt harassed by security, as he himself was open carrying a firearm.

MCVEY stated that no threats were made to him by security.

I explained to MCVEY that both sides, which would be security and himself, were likely uncomfortable due to open carrying firearms.

MCVEY wished to speak with a squad in person, Sgt. Brian FLANNERY met with MCVEY at his address of 3463 N 98th St, which is also located in the City and County of Milwaukee.

Sgt. FLANNERY and myself agreed that a license premise report documenting this incident was the most appropriate action.

Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
