The Milwaukee Police Department's investigation regarding this application revealed the following:

The below record pertains to the applicants Corporate Officer, Sheila Milton.

1. On 10/29/1981 Sheila Milton was cited by the Brookfield Police Department for Retail Theft.

2. On 05/21/09 at 11:22 pm, Milwaukee police conducted a License Premise Check at 7420 W Villard Avenue. No violations were found and all licenses were property displayed.
3. On 07/26/09 at 1:38 am, Milwaukee police were dispatched to 7420 W Villard Avenue for a Trouble With Subject complaint. Investigation revealed a fight took place inside the tavern between several patrons. A patron who was not involved then made comments to the parties that were fighting when one subject took a bat and began hitting the victim. The victim was uncooperative with police as to who struck him and refused to talk to officers. Police obtained statements from Quiana Milton and the bartender Melvin Lee regarding the incident.

4. On 11/17/2011 Sheila D. Milton was charged in Milwaukee County with Use/Unauthorized Person in Food Stamps (<\$100/1st) §49.795(6). Sheila D. Milton is listed on the application as a 50% shareholder.

6. On 05/19/2013 Milwaukee police were dispatched to a shots fired complaint at 7420 West Villard Avenue (Dee's Elegance). Investigation revealed at least two subjects exchanged gunfire in the southwest corner of the business's parking lot. Milwaukee police incident report #131390010 filed.

7. On 04/06/2014 Milwaukee police responded to a battery-dv complaint at 7420 West Villard Avenue (Dee's Elegance). The victim had left that location, but was located a short time later. The victim, Phyllis Coleman, told officers that she and Bryan Winters, who is the father of her son, were dancing at Dee's Elegance. Winters became upset with Coleman and pushed her to the floor. When Coleman left the club, Winters followed her and punched her once in the head. Milwaukee police incident report #140960012 filed.
8. On 06/10/2014 the applicant met with Milwaukee police and Assistant City Attorney Nick DeSiato regarding problems at Dee's Elegance. Nuisance ordinances were explained to the applicant who told officers she currently has a dress code, and that patrons are patted down. It was suggested that the club check all ID's, does not over serve and monitor capacity closely. The applicant indicated they are ordering a hand held swipe ID device and they had added three more sets of lights. Captain Beecher requested that the applicant submit a new plan.
9. On 06/22/2014 Milwaukee police were flagged down by security for Dee's Elegance (7420 West Villard Avenue). Officers were told that there had been a wedding party inside the business that had been arguing with another group of patrons. The wedding party was asked to leave the business, and had remained in the parking lot. Security believed that the wedding party may try to start a fight with other patrons when they left the business. Officers spoke to members of the wedding party who left the property a short time later without incident. No violations were observed.

10. On 01/26/2015 Milwaukee police responded to a shooting at 7420 West Villard Avenue (Dee's Elegance). Investigation revealed a subject who was working security for the business had shot a patron when that patron pointed a gun at him. Milwaukee police incident report #150260003 filed.

11. On 03/20/2015 officers went to Dee's Elegance, 7420 W. Villard Av, for a check with Wisconsin Department of Revenue agents. Agents located numerous bottles of alcohol that were not on invoices. The bartender stated they were gifts from customers or left over from private parties. The bottles were seized and a warning was given to maintain invoices on sight.

12. On 10/03/2015 officers were dispatched to Dee's Elegance, 7420 W. Villard Av for a Criminal Damage to Property investigation. The applicant was the caller and stated a customer left her establishment and walked across the street and intentionally damaged the fence to the business at 7501 W. Villard Av. The applicant provided video of the incident and her cooperation was pivotal to the investigation.

13. On 02/18/2016 officers were dispatched to Dee's Elegance, 7420 W. Villard Av, for a trouble with subject call. The applicant stated a customer was refusing to leave at closing time and was threatening her and her staff. The subject was on scene and told officers he was not leaving and they would have to arrest him or he wasn't leaving. He was arrested and conveyed to district 7 where he was cited for Loitering.

14. On 01/01/2017 Milwaukee police were dispatched to a shooting at 7420 West Villard Avenue (Dee's Elegance). Officers discovered a shooting victim inside the tavern. The applicant was on the scene and cooperated with the investigation. Milwaukee police incident report #170010043 filed.

15. On 01/14/2017 Milwaukee police and Alderman Johnson met with the applicant and additional parties at 7420 West Villard Avenue (Dee's Elegance). The applicant stated she has hired a new security company, has posted the age limit as 30 and up, and that she will change the music if the crowd is getting too comfortable. She is also looking into purchasing an ID scanner and a door frame metal detector. The applicant was advised to post "No Firearms Allowed" on the exterior door.

PA-33E Narrative

This Report of Incidents Involving Licensed Persons or Premises, Homicide report, was submitted by P.O. Martinez MOORE PS# 015951 assigned to District 4, Late Shift.

On Sunday, January 1, 2017, at 5:02 A.M., Squad 4365, P.O. Ralph MCCLAIN and I, was dispatched to a Shooting investigation at 7420 W. Villard Av.; Dee's Elegance.

We were assisted in our preliminary investigation by the following Squads:

Squad 4111, Sergeant Tayo ADENEKAN,
Squad 4332, P.O. Kevin ZAVADIL,
Squad 4390, P.O. Dennis MCKNIGHT,
Squad 4320, P.O. Calvin WATSON and P.O. Nicholas SCHLEI,
and Squad 4312, Sergeant Jeffrey DOLKIEWICZ

Upon our arrival at approximately 5:07 A.M., I observed a small crowd gathered in the parking lot, to the immediate south of the tavern. As I egressed from squad car, I was immediately advised by the owner, identified as Quiana L MILTON B/F, 04-19-80 address of 5817 N. 77th St; Milwaukee, WI 53218, cell phone# 364-7112, that the shooting victim was inside the tavern.

Soon thereafter, P.O. MCCLAIN and I, entered through the single swing glass door, and observed the victim, later identified as Aaron P. PRESLEY B/M, 07-04-79 (DOT address of 3522 N. 49th St; Milwaukee, WI 53216, laying in a supine position, and centrally located in the tavern. PRESLEY was observed a few feet north of the entrance door. PRESLEY was unresponsive and foaming dark red blood from his mouth. Aaron PRESLEY'S girlfriend, later identified as Shelly R WILSON B/F, 11-24-81 address of 8252 N. 61st St; Milwaukee, WI 53223, cell phone# 745-5212, was on the floor alongside him and observed frantically crying and screaming. WILSON was pleading to PRESLEY to "Get up."

P.O. MCCLAIN immediately began performing CPR on Aaron PRESLEY. I ascertained a brief description of the suspects (2) from the interior Security Officer, identified Tommy C. DICKERSON B/M, 02-20-58 address of 3334 W. Highland Blvd #3712; Milwaukee, WI 53208, cell phone# 610-3928. After obtaining the suspects preliminary description, I requested the air from the dispatcher then broadcast a description of the suspects via KSA radio.

After broadcasting the suspects description, I was escorted into the lounge room, adjoining the kitchen, by the Disc Jockey/ Security Officer, identified as Shaqill E MADISON B/M, 04-19-92. MADISON was able to effectively navigate the digital camera system to the frame of the shooting. After viewing the camera system, MADISON was able to identify one of the co-actors as "Petty." Afterwards, MADISON advised me that Petty is a close associate of the owner, Quiana MILTON. I then broadcast a more descriptive identification of the actors involved in this shooting. In addition to viewing the camera system, I also observed Robert D WILLIAMS B/M, 12-27-80 address of 7067 W Herbert Av; Milwaukee, WI 53218 discharging a firearm near the doorway. WILLIAMS is the plain clothes, exterior Security Officer, for Dee's Elegance.

After the secondary broadcast was complete, I spoke with Quiana MILTON regarding the identity of Petty. MILTON immediately gave me Petty's demographics of Shanon M. GRANT B/M, 09-24-82 (DOT address of 4129 N. 13th St; Milwaukee, WI 53209, cell phone#231-0705. Furthermore, MILTON advised me that GRANT was continuously calling her from his cell phone (previously identified as 231-0705). I then broadcast a description of GRANT'S full name and address via Open Sky. Afterwards, I informed MILTON to disregard GRANT'S phone calls.

After conversing with MILTON, Sergeant DOLKIEWICZ and I, disarmed Robert WILLIAMS in the parking lot of Dee's Elegance. WILLIAMS was armed with a .45 M&P handgun that was holstered on his right hip. Sergeant DOLKIEWICZ then rendered the firearm safe then placed it in the back of P.O. WATSON'S squad car.

After my preliminary investigation was concluded, I assisted with interior scene security. P.O. MCCLAIN assisted with exterior scene security, furthermore, P.O. MCCLAIN notified District 4 Acting Shift Commander, Sergeant Sterling HARDING, regarding the fruits of our investigation.

Afterwards, CIB arrived and was subsequently briefed by Sergeant DOLKIEWICZ and me regarding our preliminary investigation.

In conclusion, I continued to assist with scene security until the investigation was complete.

The owner, Quiana MILTON, and her staff, accommodated me in my initial investigation and their cooperation was vital in identifying a suspect in this investigation.

Villard Ave. Present was Quianna Milton (Owner), Captain Andra Williams, P.O. Carrie Resnick, myself, Brandon King (KO Security) and his partner, the DJ (Homer Blow), another female friend of Quianna's and Alderman Johnson.

Captain Williams began with stating, A gun made it into the tavern and we want to keep all businesses safe. Things happen but there are measures to take to stop them from happening. Quianna then passed out her plan to the group and we all took a minute to read it through.


Quianna stated she spoke with the Detective who handled the Homicide and it appeared to him (video), that it was possible, the security officer, may have not completed a thorough pat down, but that was just his opinion. She stated, she has currently hired a new security company called K.O. Security. She stated her license age limit is 21, but she has posted on the building 30 and up. She stated she keeps the limit at 30, but will allow family members who are 25 and older into the establishment. She has a DJ, who plays Old School hip hop and current R&B. The DJ know how to read the crowd and will change the music if the crowd is getting to comfortable.

Quianna stated she will be keeping an open line of communication with District Four and will call into the District if she does not get good vibes from the crowd. She loves it when the officers stop by and walk through.

She is looking into purchasing an ID scanner as well as the door frame metal detector.

She was advised to post "No Firearms allowed" on the exterior door as well.

We would like for you and our customers to know that we are 100% committed to providing them a safe and fun atmosphere for night time entertainment.

Milwaukee is currently experiencing an abundance of bad behavior, in addition to an increase in our area being that several establishments have closed. We began to make changes early on by increasing our age to 30 and up and strictly enforcing our no white t-shirt rule. In order to continue moving forward on a positive note we have implemented the following changes and have ensured that our employees will follow these changes as well:

Everyone

- Will give accurate details and information to MPD upon request
- Beware of unwanted behavior at all times
- Contact MPD prior to an escalated situation
- No in and outs. Only 2 smoke breaks
- People already intoxicated will not obtain entry

Bartenders

- If you see a patron that has had too much you should not continue to serve them nor allow any other patron to purchase drinks for them.
- You can ask to view IDs to ensure patron is the appropriate age
- Will remove any glassware from tables if not being used by a patron

Security Guards

- Perform a thorough search for all male patrons and search all women's purses
 - For any entry and re-entry
- Walk thru metal detector which identifies areas of concern
- Check IDs and ensure all patrons are 25 and older no exceptions
 - Though license says 21 we still operate as 25 and up (we maintain an older crowd)
 - Handheld ID Scanner for all Patrons
- Will remove any glassware from tables if not being used by a patron

Dress Code

- NO PLAIN WHITE T-SHIRTS (Friday-Sunday)
- No sagging Jeans for Males
- Hats must be worn forward at all times
- No weapons of any kind at any time
- Men must be well groomed
- Women must be appropriately dressed

Signage

- Must be 25 or older to enter premises
- Unwanted or Violent Behavior of any kind can result in immediate removal and possibly legal prosecution
- No plain white Ts
- Weapons of any kind are not permitted on the property (No Conceal to Carry)

Property Improvements currently working on

- Improve lighting on the outside of the building
- Security Camera technician to ensure camera position monthly
- Obtaining hand held ID swiping machine (In process)

NOTICE TO EMPLOYEES: FAILURE TO COMPLY WITH ANY OF THE RULES ABOVE WILL RESULT IN WRITE-UPS AND/OR IMMEDIATE TERMINATION

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.




