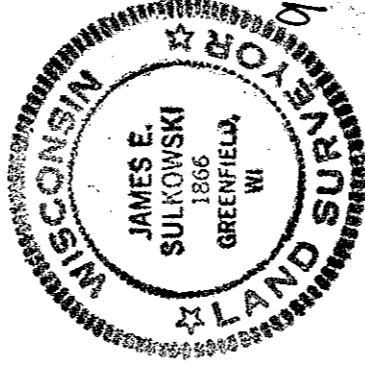
That I have surveyed, divided and mapped a Redivision of Lots 23 and 24, in Block 49 in J.L. PIERCE'S SUBDIVISION
