This report is written by Police Officer Gilbert Gwinn, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05-03-05 at 11:15pm, Milwaukee Police were sent to 5881 S Howell Ave (Airport Lounge) for a Trouble with Subject call. Officers spoke with the manager on scene (Nikolaos Tsitsos w/m 03-02-51) who stated a patron refused to pay for drinks that he had ordered and had called one of his dancers a whore. This subject was identified as Ronald L Hansen (w/m 06-01-72) and was found to be highly intoxicated. Officers then spoke with Hansen who stated he refused to pay for the drinks because one of the dancers had punched him in the face with a closed fist. He insisted on pressing charges for battery. This dancer was identified as Kimberly C. Weiland (w/f 02-07-77). Weiland was issued a citation for Assault and Battery and Hansen received a citation for Disorderly Conduct and Theft.

2. On 09-24-05, Milwaukee Police were dispatched to 5881 S Howell Avenue for a fight. Investigation revealed that a patron that had left the bar got into a verbal argument with another patron in the parking lot and one subject armed himself with a bat. Once police arrived, all subjects were gone except for the subject with the bat. He was identified as Michael Brantley (b/m 11-03-65) and was issued a citation for Disorderly Conduct. No other violations were found.

3. On 05/25/10 at 2:11 am, Milwaukee police were dispatched to 5881 S Howell Avenue for a Subject With Weapon. Officers were met by the taverns security who stated there was a subject in the parking lot armed with a knife. Officers approached the suspect and ordered him to drop the knife in which he did, and the suspect was placed under arrest. Police spoke to Nikolaos Tsitsos who stated the subject was very intoxicated and was escorted out of the bar by security. The subject insisted on staying in the parking lot to wait for the women employees so he could talk to them but was asked to leave the area. The subject refused and became argumentative. He then began to walk around the business where the women parked their cars and when security attempted to stop him, he pulled out a pocketknife and started to wave it around. Security fearing for their safety, pepper sprayed the subject and called for police.

Investigation revealed that two dancers employed by the business became involved in a fight. Neither one of the involved subjects wanted to prosecute the other and no citations or other police reports were filed. No license violations were observed.
