2. On 10/14/22 at 2:20p.m., Milwaukee Police conducted a License Premise Check at 3455 N. Martin Luther King Jr Dr. This was in regards to a Shots Fired which took place outside of the store on 10/08/22 at 3:58p.m. Investigation revealed a patron had purchased a pizza for a youth inside the store, however, the cashier accused the youth of trying to steal the pizza, which caused a heated argument between patrons and the cashier. Another employee attempted to intervene and escort the crowd outside, however, was assaulted outside. The same employee returned inside the store and armed themselves with a firearm and went back outside, exchanging gunfire with a patron. Officers reviewed video surveillance and the armed employee was arrested. The employee was cooperative with the investigation.

- 3. On 10/14/22 at 7:37p.m., Milwaukee Police were dispatched to a Subject Wanted at 3455 N. Martin Luther King Jr Dr. On arrival officers identified the subject as an employee and were able to place the subject into custody with no further incident.
- 4. On 10/29/22 at 4:11p.m., Milwaukee Police were dispatched to a Subject with Gun at 3455 N. Martin Luther King Jr Dr. Investigation revealed a customer and employee were in a verbal argument, when the customer began making threats. The employee armed themselves with a rifle and demanded the customer exit the premise. The employee was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 5. On 12/01/22 at 11:25a.m., Milwaukee Police were dispatched to a Reckless Use of a Weapon at 3455 N. Martin Luther King Jr Dr. Investigation revealed the employee observed what they perceived to be inappropriate behavior between a customer and possibly their son. When the employee advised the customer that type of behavior was not allowed, the customer pulled a gun, pointing it at the employee and making threats. The employee was cooperative with the investigation.
- 6. On 05/03/23 at 8:25p.m., Milwaukee Police were dispatched to a Threat at 3455 N. Martin Luther King Jr Dr. Investigation revealed a customer purchased a pizza, however, it was not cooked to their liking, therefore they requested a refund. The store has a posted no refund policy and offered to make a new pizza, however, the customer refused it and called the police to get their money back. The employees were cooperative with the investigation.
- 7. On 05/08/23 at 11:24a.m., Milwaukee Police were dispatched to a Battery at 3455 N. Martin Luther King Jr Dr. Officers were advised by the clerk two patrons were involved in an incident, however, had both left prior to police arrival.
- 8. On 07/04/23 at 11:39a.m., Milwaukee Police were dispatched to a Trouble with Subject at 3455 N. Martin Luther King Jr Dr. Investigation revealed the employee called the police after accusing a patron of stealing fireworks. Investigation revealed the employee actually placed the fireworks in the patron's bag by accident. The employee was cooperative and apologetic.

#### LICENSED PREMISED REPORT

This report is being written by PO Stephen COLWELL, assigned to District Five, Early Power Shift, Squad 5266.

On Friday, October 14th, 2022, at 2:20 PM, I conducted a Licensed Premise report at Action Food & Liquor, located at 3455 N Dr Martin Luther King JR Dr, which is in the City and County of Milwaukee.

I conducted this license premise report following a Shots Fired Incident which occurred outside the store on 10/8/22 at 3:58PM.

Synopsis of incident on 10/8/22:

A store employee, identified as Martin K STENNIS (B/M, 3/19/1978), stated he was making food near the rear of the store when a patron purchased a pizza for a child who appeared hungry. The employee working the register, identified as Jamil I OWAIS (W/M, 1/9/1998), accused the child of trying to steal the pizza, which upset a male patron. STENNIS stated OWAIS and this unidentified male patron started yelling and shouting at each other, causing more patrons to enter the store to confront OWAIS. STENNIS stated these subjects then began to damage property by knocking over displays and breaking bottles of liquor on the floor. STENNIS stated a female employee, identified as Felicia D DAVIS (B/F, 12/6/1994), walked to the front of the store to intervene in the situation. STENNIS stated DAVIS was near him in the rear of the store when this incident began, and her primary job was to clean and stock shelves. STENNIS stated as the several patrons left the store and DAVIS followed them out. STENNIS stated he remained inside the store with DAVIS' son who was seated next to him in the rear of the store. STENNIS stated DAVIS then reentered the store with blood on her face and stated she had been assaulted. STENNIS stated he did not observe DAVIS leave the store again.

When officers reviewed camera footage, they observed the incident inside the store described by STENNIS. Officers who reviewed camera footage stated after DAVIS was assaulted outside the store, she returned to the inside of the store and retrieved a black firearm and exited the store a second time. Officers stated when DAVIS left the store a second time, DAVIS and an unknown black male wearing a purple hooded sweatshirt exchanged gunfire with each other. DAVIS' biological sister, Tatiana M HARDIN (B/F, 5/4/1996), was also on scene when the incident occurred. After DAVIS returned to the store, she placed the firearm inside a black purse. HARDIN took possession of this purse and took it with her as she left the scene in a blue vehicle. HARDIN would eventually return to the scene on foot and spoke to officers but was uncooperative. DAVIS was arrested on scene for Endangering Safety by Use of Dangerous Weapon. HARDIN was also arrested for Resist/Obstruct.

Prior to conducting this licensed premise investigation, I located the following active licenses; 1) Cigarette and Tobacco 2) Class A Mait & Class A Liquor License 3) Food Dealer Retail. When I returned to the Action Food & Liquor, I spoke to the employee working the register who was later identified as Jamil OWAIS. OWAIS stated his brother, Mohammed I OWAIS (W/M, 9/11/1984), is the business agent and owner of the store. J OWAIS stated both he and M OWAIS work at the store.

J OWAIS stated the store hours are from 8:00AM - 9:00PM seven days a week. There are several operational cameras both inside and outside the store and it should be noted J OWAIS was cooperative with police during their initial investigation of the incident on 10/8/22. J OWAIS stated he believed the camera footage is stored for 24 hours. The City of Milwaukee issued licenses were prominently displayed for public view behind the cash register area and did have M OWAIS as the listed business agent.

J OWAIS stated DAVIS had been working at the store for approximately two weeks prior to the incident on 10/8/21. J OWAIS stated DAVIS had since "quit" and is no longer an employee. J OWAIS was cooperative during my contact with him.

The interior and exterior of the store were relatively clean and free of litter or debris.

On Friday October 14th, 2022, at approximately 7:37 Pm Po HOLSEN and I were dispatched to a subject wanted call at 3455 N Martin L King Jr. Dr. "Action Food & Liquor". Before PO HOLSEN and I arrived at the location wanted check revealed Jamil OWIES (W/M 01/09/1998) had a Suspect Alert for 2nd degree Sexual Assault. Upon arrival at the store, I identified OWIES from a prior booking photo behind the service counter at the location. When OWIES was asked his name was "Jamil" he stated, "yes" and was asked to come out from behind the counter. OWIES was taken into custody without incident and transported to District 5 booking room for processing.

This suspect alert is submitted by Detective Andrew FARINA, assigned to the Sensitive Crimes Division, Squad 3726.

It should be noted that the Owner who identified himself as Mohammad I OWAIS (W/M 9/11/1984) was enscene during the arrest and attempted to interject himself multiple times into the situation. OWAIS did not physically attempt to free OWIES but was visibly upset when we told him we were not at liberty to discuss OWIES's case with him.

#### INITIAL INVESTIGATION

This report is being written by PO Constantine SPENCE, assigned to Early shift, District five.

On Saturday, October 29, 2022, I along with my partner PO Morgan KLIPP; were assigned to squad 5291, dressed in Milwaukee Police Department uniform, equipped with Axon body camera.

At 4:11 PM we were dispatched to a Subject with Gun which is located at 3455 N Martin Luther King Jr Dr, in the City and County of Milwaukee Wisconsin. Upon arrival we spoke with OWAIS, Mohammad I (A/M 09-11-84).

#### Interview with OWAIS

Mohammad stated he is the manager/cashier of the store and stated a customer was extremely aggressive during his transaction. The customer/caller is identified as WEATHERALL, Richard C (B/M 04-08-89). Mohammed stated Richard skipped two customers in front of him to place his order. Mohammad stated Richard was upset because the price for one of items purchased increased in price. Mohammed stated Richard insulted him and stated he was going to kill Mohammad.

Mohammad stated he asked Richard to leave the store because of his threatening comments. Mohammad stated Richard refused, continuing to insult Mohammad. Mohammad stated he grabbed his rifle and demanded Richard to leave the store.

## **Footage**

Officers reviewed cameras of the incident that occurred between cashier and customer between the time of 2-3pm. The footage showed the cashier having a rifle in his possession and asking the customer to leave the store. There is no audio in the footage to hear the conversion between Richard and Mohammed. Mohammad was never shown pointing the rifle at Richard. The was rifle was shown in his right hand by his side.

A check of CCAP shows cashier had no felony convictions or open cases. Wisconsin dot check shows Mohammad is not on probation or parole, and is not prohibited from possessing a firearm in his private property.

It should noted that Mohammad cooperated with officers and allowed officers to recover video footage of the incident.

On Thursday, December 1st, 2022, Officer Brian MATTE and I (sq 5165) were dispatched to a reckless use of a weapon complaint at Action Food & Liquor located at 3455 N Martin Luther King Jr Dr.

Upon arrival we met with the caller/victim Mohammad OWAIS (w/m, 09-11-84) who stated that an unknown customer was in the store pushing a little boy who was about 8 years old (assumed to be the suspect's son). OWAIS informed the suspect that he does not allow that behavior in his store then he asked the suspect to leave. OWAIS and the suspect were in the store's aisle. The suspect then pulled out a black handgun with an extended magazine. The suspect then pointed it at OWAIS and the clerk, Jamil OWIES, who was standing behind the counter. The suspect then said, "I'm coming back tonight and show you. I'm gonna shoot you and the store up." The suspect and his son then left the store then walked southbound on MLK Dr.

The two victims stated they feared for their lives and did not consent to the suspects actions. They wish to prosecute him for this offense.

The victims stated they have seen the suspect many times in the store, and this was the first time they have had problems with him. They believe he lives close to the store. They think the suspect was the victim of a shooting about four or five months ago somewhere near MLK Dr. They believe the suspect was shot in his legs because he walks with an obvious limp now. The suspect is described as a black male about 30-40 years of age.

The licensed establishment was cooperative during the investigation.

This incident was captured on the store's video. I was able to export the video onto my department issued USB drive.

Upon our amival, I observed a woman sitting inside of her vehicle on the west side of the building. Once inside of the store, I observed multiple customers and 2 workers behind the front counter. I observed the pizza box on the counter containing a pizza which was crispy around the edges.

I spoke to the caller, who identified herself as Beanita M. LEWIS (B/F, 11/06/1975 ph. 414-553-3956) who stated she purchased a pizza from the store and the pizza was too well done for her liking. LEWIS stated she notified the worker, and the worker told her there was nothing he could do about it. LEWIS stated the workers did not want to give her, her money back after asking for a refund. LEWIS and the worker exchanged words and LEWIS felt the need to call police to help her get her money back.

I spoke to licensed premise employee Jamil I. OWIES (W/M, 01/09/1998) who stated he offered the caller a new pizza free of charge, she only had to pay for the extra cheese she wanted. OWIES stated he never threatened LEWIS but told her there is a no refund policy which was visibly posted inside of the establishment. No one felt the need to call the police due to the caller notifying them she was calling. The business was cooperative with the investigation. The business did not have any security officers on scene.

I did not review any video surveillance footage, due to the type of call.

While on scene, I observed the licenses posted and they were up to date. During my investigation for a threat, I did not observe any violations in the licensed premise.


