

Notice is hereby given that an ordinance (passage of which is now pending) was introduced at the May 3, 2005 meeting of the Milwaukee Common Council, the essence of which is as follows.

Ordinance relating to the change in zoning from a General Planned Development to a Detailed Planned Development known as Park East Enterprise Lofts, on land located on the West Side of North Dr. Martin Luther King Jr. Drive and North of West Vilet Street, in the 6th Alderman District IDCD the 6th Aldermanic District. (DCD)

The Mayor and Common Council of the City of Milwaukee ("Common Coun-cil"), do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances "Code") a new section to read as follows:
Section 295-907(2)(b) 0077

(I) In accordance with the provisions of Section 295-907 of the Code relating to the establishment of planned development districts, the Common Council approves the subject Detailed Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk and made a part as

of the City Clerk and made a part as though fully set forth herein.

(2) The zoning map is amended to change the zoning for the area bounded and described by the zoning line within the right-of-way of North Dr. Martin Luther King Jr. Drive, the zoning line within the right-of-way of West Vliet Street a line 32147 feet North and parallel to the north line of West Vliet Street and a line 160.68 feet West and parallel to the west line of North Dr. Martin Luther King Jr. Drive.

(3) The requirements set forth in said

(3) The requirements set forth in said detailed plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for the area contained in such planned development district described, provided further, that the effect of the approval of such detailed plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the detailed plan to all conditions and limitations set forth in such detailed plan. such detailed plan

Part 2 Any persons, firm, company or corporation owning, controlling, or managing any building or premises wherein or whereon there shall be placed or there exists anything in vio-lation of the terms of this ordinance, or who shall build contrary to the plans or specifications submitted to and approved by the Commissioner of the Department of City Development, or any person, firm, company or corporation

who shall omit, neglect or refuse to do any act required in this ordinance shall be subject to the penalties provided in Section 200-19 of the Code.

Part 3 In accordance with the provisions of Section 295-907 of the Code the City Clerk shall transmit a certified copy of the action taken by the Common Council to the Department of City
