Good afternoon Marina! I'm sure you seen by now or have gotten an email about the noise complaint outside of Pink Agave last night. I'm reaching out to those customers on my behalf for not going outside and telling them to tone down the noise and be mindful of the neighbors. They weren't fighting or destroying city property- just simply outside talking and laughing amongst themselves.

They filed a noise complaint and when I checked the cameras today from last night, I seen a police officer walk in to Pink Agave and when he went to look for someone behind the bar I JUST walked back to the kitchen. So he didn't see me and walked out. I only had 3 customers by the time he got there so I was wrapping up and trying to start closing procedures. But I did call the district today when I noticed that to talk to the police officer and he told us he just wanted to advise us to tell those costumers that WERE(they had already left) outside to quiet down.

I know I'll be seeing you tomorrow but I know we usually like to communicate with each other if anything like this pops up. So I just wanted to reach out and tell you my side before I see you tomorrow.

— I wanted to mention one procedural point. The committee won't be able to view the videos because, given their recency, there wasn't time to properly notice the applicant that they would be included. However, you can testify under oath about what you witnessed last night, and that carries significant weight with the committee. When it is time for public testimony the chairperson will give you three minutes to narrate what you have seen and then provide the committee, Terri and or Alderwoman Dimitrijevic, and the applicant an opportunity to ask you clarifying questions.

Since you mentioned concerns about security, the business's plan of operation indicates that they have one security person responsible for checking IDs and maintaining a safe environment.

Hello, I am resident who has been living at \_\_\_\_\_ for 5 years. At approximately 10:45pm last night about 7-8 patrons came out of Pink Agave in Kinnickinnic Ave and proceeded to be loud and disorderly consuming alcohol out in front of the establishment and being loud enough to disturb in the entire neighborhood for over 20 minutes. When I had opened my window to yell at them to quiet down, and head home I got the response included in the second video. Threatening my life and general unruly disruptive behavior. No one inside Pink Agave came out to inform thier patrons to disperse, leave, quiet down, etc...

There was no sign of security, a bouncer, or a door man/woman. There have been repeated noise disturbances from Pink Agave and Revel and Sunday nights it has seemed to have escalated recently and it seems patrons in these establishments try to extend thier drinking weekend. I am a working professional at Molson Coors Beverage Co and I respect a business in the service industry to serve thier patrons. This repeated behavior is unacceptable however. I know children living in the unit next to mine. I have some hotlinks to Google photos/videos. If you can't view these please reply will find another way to format and send over. I did call MPD 2nd district immediately after the incident.
