This office is in receipt of your claim in the amount of \$1,031.19, relating to damage allegedly sustained to your vehicle on March 12, 2001, when it was struck by a falling tree branch at North Cass Street and East Brady Street.

The Forestry Division records indicate the damage to your vehicle does not appear to be consistent with damage caused by a falling tree branch. As such the City can not accept liability for your loss. Accordingly, we are denying your claim.
