
This office is in receipt of your claim in the amount of \$300.00, relating to your loss on January 11, 2004 while parked in the Plankinton Avenue parking garage.

Our investigation reveals that your loss was not caused by the negligence of City of Milwaukee. The Department of Public Works (DPW) records note the parking ticket dispensed at the entrance to the parking ramp noted they do not provide guards or assume liability for criminal acts. Since the City did not cause your loss, it cannot accept liability. Accordingly, we are denying your claim.
