

On October 30, 2015 at 1:00 pm the Milwaukee Police Department damaged my front storm door and entry door due to a no knock warrant. I received a call voice mail around 12:00-12:30 that afternoon and wasn't given enough time to get to my house before they entered the premises themselves. At the time of the search they damaged the front storm and entry door at 327 W. Armour Ave Milwaukee, WI 53207. The handle on my vase was broken off from the officers dumping it on the floor looking for the items in question. The picture on my television also shows a black screen down the middle from the officers. The leg of my couch was broken off more than likely from them lifting the couch and looking under and letting the couch slam back to the ground and my daughters watch was scratch from being thrown on the floor in her room when they searched her room. I enclosed copies of receipts for these items along with pictures of the damaged items. Estimate of the damages are \$1260.00.
