We would like to appeal the decision that was made about the Milwaukee police department which use forced entry at our rental property at 4909 N. 50th street Milwaukee Wi 53218.

We went to district 7th station to talk with Officer Pierce about the letter that was sent regarding our property being a public nuisance.

We discussed about what to do finding out about a person living on the property that we did not know was living there... We rented the property to Johnny Jones but we found out a Prezell Bobbitt was living there so we wanted to take the proper and right steps to convict Prezell off the property.

The day the search warrant was conducted we were never informed about how too contact the city for damages caused by its officers. It wasn't until making an open records request that we learned about making a claim against the city for damages. If Sargent Mark Kapusta had given us this form on the day of the warrant, we would have filed this claim sooner.

We also were never informed that we needed to submit a letter to the city and have it mailed out at a certain time limit. Once we found out that we had to submit a letter we acted accordingly to submit the letter out. We have been going through so much trying to vacate the person that was living there that was not supposed to be living there off the premises.

We had to fix the damage doors so we can rent it out. The person also left more damages when he moved out. We have a lot of repairs to complete because of all the damages that was made but the officers and the wrong tenant. We are trying to do this matter the right way and all we are asking is the cost of the damages that was made by your officers no more or no less.

We have received your claim in the amount of \$1,969.03 relating to damage from a loss on February 14, 2017.


This notice of claim was filed on January 8, 2018. Wisconsin Statute §893.80(1d)(a) requires that a notice of the circumstances of the claim be filed within 120 days after the happening of the event giving rise to the claim. This notice is untimely.

The Milwaukee Police Department indicates that they executed a lawful search warrant which necessitated the use of forced entry. This use of force is authorized by §968.14 of the Wisconsin Statutes and, therefore the City of Milwaukee is not liable. As such, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

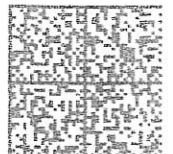

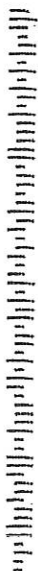

On October 22, 2016 Johnny Jones signed a one year contract as our tenant at 4909 N. 50th Street Milwaukee, Wisconsin 53218. On February 14, 2017 we received a call from the tenant living in the lower lever at 4911 N. 50th Street Milwaukee, Wi 53218 that police officers came to the sight for a possible drug raid.

We never had any problems with any of our tenants with drugs.

Prezell Bobbitt was issued a warrant and was taken into custody for drug trafficking, we never rented to a Prezell Bobbitt and we never knew he was living on the property.

During that process the police officers damaged the outside storm door, the inside entry door, the upper entry door at 4909 and damages to the garage door. I, the landlord was never notified of any warrant or any of the activities that took place causing all these damages made to my property.

I'm asking for the Milwaukee Police Department to pay the cost of the damages that was made by your officers. Here are the receipts for the cost of replacing the doors and the cost of the repairs.

We had to vacant Prezell Bobbitt off the property how was living there and he was never supposed to be living on the property. The replacements doors and repairs are completed. Receipts and pictures are included.

As the owner and or operator of this property, you must take **IMMEDIATE** action to abate the nuisance activity at this property. If you fail to respond to this notice and/or fail take action to abate subsequent nuisance activity, Wisconsin law permits the City of Milwaukee to seek a court order declaring the property a public nuisance and ordering the property closed and sold with proceeds retained by the City to pay abatement costs, liens, and the remainder split between law enforcement, alcohol and drug abuse assistance programs and community development organizations.

Please review the following nuisance abatement measures that you may employ to prevent the continuance or reoccurrence of drug dealing and other nuisance activity at your property. These suggestions are not exclusive and you may use other nuisance abatement measures that are appropriate in the particular circumstances of your property:

- Participate in a local block watch or neighborhood association.

On Tuesday, February 14, 2017 Police Officers from the Tactical Enforcement Unit and District Four executed a "No Knock" Search warrant at 4909 N 50th St, in the City and County of Milwaukee. During the execution of the warrant the officers located the target of the warrant, Prezell L Bobbitt B/M 04-30-68, inside of the residence.

During a search of the residence officers located a clear plastic bag filled with a white powdery substance and a clear plastic bag filled with an off white chunky substance, suspected cocaine, from a sock in the northwest bedroom, a glass jar with suspected marijuana on the kitchen table, and a pill bottle that contained 17 small round pills with A215 imprint, suspected Schedule II narcotic. Officers also located a loaded Heckler and Koch 40 caliber handgun (serial# _____) and a loaded Charter Arms 38 caliber revolver (serial# _____) in the attic space above the kitchen. Officers also located 2 digital gram scales and a box of sandwich bags, items all common in the sale of narcotics.

BOBBITT was arrested and conveyed to District #4 for processing. At District #4 P.O. James JORDAN tested the suspected cocaine using the Nark II field test pouch #07 which tested positive for cocaine and weighed a total of 5.3 grams. P.O. The following officers were part of the search and containment team: P.O. Christopher NAVARRETTE, P.O. James JORDAN, P.O. Matthew ZAWORSKI, P.O. Jacob WASECHEK, P.O. Carrie POCERNICH, P.O. Jerome BATTLES, DEA Agent James KRUEGER, DCI Special Agent Bodo GAJEVIC and myself.

The residence 4909 N. 50th St. is an upper unit of a 2 family residence. Upon entry to the side door, you enter a common hallway and a staircase that leads to the upper. At the top of the stairs is a door that leads into the

residence. Upon entry to the residence, the living room is to the east. A hallway leads to a bathroom, 2 bedrooms, and a kitchen to the west. There is an attic space that is located on the northside of the kitchen ceiling.

When officers were conducting the search BOBBITT informed P.O. POCERNICH that what we were looking for was in a sock in his bedroom and that there were 2 guns in the attic.

Search of the kitchen

I, P.O. CONWAY, located a clear, glass jar on the kitchen table filled with a green, leafy substance, suspected marijuana. Also on this table was a black and chrome digital gram scale, box of sandwich bags and a glass plate with white residue on it. There also was a WE energies bill and paperwork from the Department of Transportation (DOT) with the name Prezell BOBBITT on the kitchen table.

P.O. JORDAN searched the kitchen cabinets and located a large digital gram scale in the upper southwest cabinet. P.O. JORDAN also located a glass plate that contained a white powdery substance, suspected cocaine, with a razor and 2 business cards in South East cabinet.

Search of the Northwest bedroom

DEA Agent James KRUEGER and DCI Special Agent Bodo GAJEVIC, along with myself searched the northwest bedroom. Special Agent GAJEVIC searched a laundry basket, along the north wall and found a rolled up sock that contained 2, clear, plastic bags. One of the bags contained a white, powdery substance, and the other clear, plastic bag was filled with an off white, chunky substance, each suspected cocaine.

DEA Agent KRUEGER located an orange prescription pill bottle in the second drawer from the top in the dresser, along the west wall. Inside this bottle was 17, small, round pills with an A215 imprint, suspected Schedule II narcotic. This pill bottle had the name of Jeanette BOBBITT.

I, P.O. CONWAY, located one (1) unfired Smith and Wesson .40 caliber cartridge on the TV stand, along the east wall.

Search of the Attic

P.O. NAVARRETTE and Agent GAJEVIC located a loaded (9-Winchester S&W .40 caliber ammunition) Heckler and Koch .40 caliber handgun (serial#:) and a loaded (5-CBC 38 SPL ammunition) Quarter Arms .38 caliber revolver (serial#) in the attic space above the kitchen.

I, P.O. CONWAY, took photographs of the evidence recovered in the residence.

BOBBITT was arrested and conveyed to District #4 for processing.

At District #4, P.O. James JORDAN tested the suspected cocaine using the Nark II field test pouch #07, which tested positive for cocaine and weighed a total of 5.3 grams (0.1 kitchen cabinet (1a), 2.1 grams (1b) and 3.1 grams (1c) from sock. P.O. JORDAN tested the suspected marijuana using the Nark II field test pouch #05, which tested positive for THC and weighed 7.3 grams. P.O. JORDAN identified the pills, as Oxycodone Hydrochloride using Drugs.com with a total weight of 1.8 grams. The weight, packaging, and different drugs located is consistent with the sale of narcotics.

BOBBITT is a convicted felon and has a prior drug conviction under case #91CF912443. BOBBITT knowingly maintained a residence for the storage, packaging, and distribution of narcotics.

The firearms, ammunition, original containers of the marijuana and powder cocaine, and scales were conveyed to the Forensic section for processing.

P.O. NAVARRETTE and P.O. ZAWORSKI interviewed BOBBITT and will be filing a separate supplement report regarding.
