Dear Ms. Blackdeer:

This is to notify you that on Monday, March 9, 2009, the City's Licenses Committee voted to recommend to the City's Common Council that your application for a Class "D" Bartender license be denied. The Committee made such a recommendation based upon the police report, which was provided to you along with the notice of hearing.

On Wednesday, March 25, 2009, the Common Council considered the Committee's recommendation regarding your application. On that date, the Common Council adopted the Committee's recommendation and denied your application.

You are eligible for a refund of your license fees, except for a \$25 administrative fee, by bringing in your receipt or filing an application for a refund within one year to date of council action with the License Division, Room 105, City Hall. Pursuant to sec. 90-5-9-c, Milwaukee Code of Ordinances, **you may not reapply for a license within 12 months of the date of denial.**


