We have received your claim for the amount of \$425.00 in relation to the damage you sustained to your lawn mower at 3300 South 16<sup>th</sup> Street.



The sign crew found a sign mounting post in the grass at this location with a missing pipe and sign. The City of Milwaukee did not remove this sign, and had no prior knowledge that the sign was missing.

The damage to your lawn mower was not the result of any negligence of the City of Milwaukee, and therefore the city is not legally liable for your damages.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
