One of the noise nuisance calls was at 7:11pm where our guests were having a dinner cookout. He could have kindly asked them to quiet down, or contact us, instead he decided to involve the police. Again, he's trying to do whatever he can to shut our business down.

There is another airbnb directly next door and a few others on the block. He's been contacting VRBO and Airbnb every week saying that they are "ruining the neighborhood." You'll see that all calls come from him and no other neighbors on the block.

We run 9 similar size short term rentals in the City of Milwaukee and have no other issues with any neighbors. We live in the city and care about the neighborhoods that we own properties in. We vet our guests and communicate with them on the need to keep noise down in the evenings.

We will continue to ensure our guests do not create nuisances, but unfortunately this neighbor's vendetta against our business is out of our control.
