Dear Mr. Dotson:


This office is in receipt of your claim in the amount of \$300.00, relating to damage sustained to your vehicle on January 17, 2004 when you allege a City snowplow threw slush onto your windshield while traveling on West Villard Avenue, between North 46th Street and 47th Street causing it to crack.

Our investigation reveals that the Support Services Division had no notice or records regarding this alleged incident until your claim was filed. The vehicle investigator assigned to this incident also noted there was no Police Accident Report regarding the incident. When the accident investigator spoke with you, you could only speak with him briefly. You were unable to provide any truck or license number or any other hard evidence to investigate this alleged claim further. Since there is no evidence the City was negligent in this alleged incident, it cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
