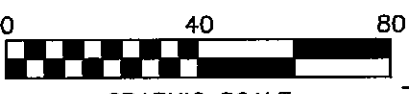

Beaty, Registered Land Surveyor, do hereby certify that at the direction of the Owner(s), I have made this survey, Being a redivision of Lot's 2,3,4, 5 and the north 124.49 feet of Lot 1, in Block 2, Gosch-Field Subdivision being also a part of the Southwest 1/4 of the Northeast 1/4 of Section 17, Town 7 North, Range 22 East, in the City of Milwaukee, County of Milwaukee, State of Wisconsin, said lands are bounded and described as follows:

Commencing at the Southeast corner of the Northeast 1/4 of said Section 17; thence S89°08'16"W a distance of 2428.14 feet along the south line of the Northeast 1/4 of Section 17 to a point; thence N00°52'40"W along the east line of N. 5th St. a distance of 150.00 feet to the point of beginning of the lands hereafter described; thence continuing along said east line N00°52'40"W a distance of 164.16 feet to the south line of W. Christine Ln; thence N89°08'16"E a distance of 197.27 feet along the south line of W. This agreement shall be binding on the undersigned and assigns.

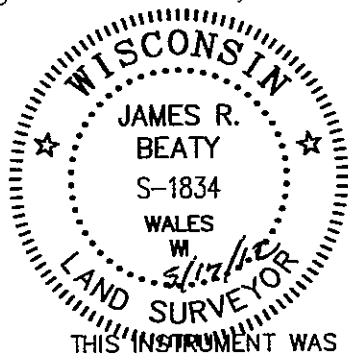
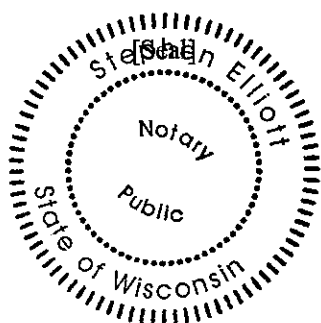

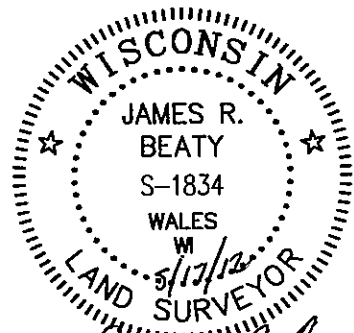
