
This office is in receipt of your claim in the amount of \$758.95, relating to damage sustained to your vehicle on 08/10/01 when you struck a garbage cart while exiting your garage at 2635 South 15th Street.

Our investigation reveals that the collection crew, which serviced your alley, denies that they left the garbage cart in the middle of the alley and no evidence was submitted by you to support your allegation. Therefore, in the absence of proof to the contrary we must take credence in the testimony of the collection crew and not accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
