To whom it may concern;

I am sending this at your request as a follow up to the phone conversation i just had at your office. Last night i had a terrible experience with a taxi fair and subsequently would like to file a formal complaint against him. Here is the situation:

I arrived at the Milwaukee airport around 9:00 pm last evening. Upon arriving at the Taxi Stand i asked the driver if he accepts credit cards, at which he replied he does. Being a regular business traveler this is the only way i can keep up with my expenses.

Upon sitting in the taxi (before we drove away) i instructed the driver to take me to the Clarion Hotel and Conference center, at which point, he said no. He told me that they offered free shuttles and that he had been waiting 3 hours for my fair. At that point, i said, unfortunately i did not arrange for the shuttle, and they are not here, so i'd like to pay if he'll drive me. His response was i'd have to pay for his 3 hour wait plus the fair - which of course is ridiculous. We agreed that i would pay the \$11 min fair at which point he left. For the next 10 minutes the driver was visibly and audibly upset with me, driving extremely fast, stopping short, and taking hard jolting turns.

When we arrived at the Clarion he then tells me that he doesn't accept credit card (which was clearly because he didn't start the fair in his car and wanted to pocket all \$11). This is a problem for me as i don't have cash and would have never gotten in his taxi if he didn't accept credit. The taxi driver then forces me to go to an ATM machine (at a gas station - that he drove me too). After i got the money, he then drove me back to the hotel, and told me that he would take me directly to the sheriff if i didn't pay the \$11 (despite the min fair being clearly labelled in his car as \$10). At that point i took down your phone number which was posted in the taxi and told him i intended on calling you and filing a complaint - at which point he stopped the car and told me to get the F&CK out of his cab on the side of the street. I had to walk to my hotel last night in a city that i had never been before. And i had to give him \$11 to get my bag out of his trunk.

I hope this behavior is not indicative of acceptable practice in your city by your taxi drivers. This is my first time to Milwaukee and as you can imagine my experience has been less than adequate.

I did not get the name of the driver or the name of the company as it wasn't clearly indicated on the car. The car was a white sedan and the taxi car number was #104.

I sincerely hope that you take all action available to you against this driver before he pulls the same actions on someone not as capable of handling themselves as me. It is your responsibility to do so!



Dear Licensing ,

I have spoke with you before this date regarding a problem I had with A Taxi Cab Driver Calling me, and harassing me because I didn't take his cab.

The Driver was from American United Cab Company here is Milwaukee. I Tried several times to contact American United Taxi to make a formal complaint, and left messages for their office, but none of my phone call messages were returned. I guess, that American United doesn't take the matter seriously, even though state statutes prohibit harassment , and that they don't think it's a seriously concern. I hope your Department has some luck or power in compelling American United to take this serious , and to extract more information from them.

Being somewhat Computer illiterate ,and personal agendas, it's taken me a couple weeks to file this complaint.

The Incident with the Taxi Cab Driver is as follows;

- 1) On 5 April 2013, I called American United Taxi to come pick me up at Walmart on Hwy 100 & Layton avenue. This was at ( 9:15 pm). American United said they would send out a cab, and asked me for a call back number which I provided them.
- 2) At 9:22 pm, a taxi driver from United American called me back on my cell phone number, and said he would be there in 15 - 20 minutes. His phone number is listed as ( 414 - 335- 3402).

3) Around 9:25 pm, A United Taxi Cab showed up at Walmart but at the other doors in front of the store, I waved down the Taxi driver because sometimes they don't know what doors to go to. The Cab driver then saw me flag him down and stopped. I said my name is \_\_\_\_\_ (the name I gave the dispatcher from United American) , and he stated that he was just dropping off someone at the other doors, and said he can take me where I want to go. At that time I was cold, and freezing, and said to him to cancel the other cab, as I was putting my items into his trunk that I bought at Walmart.

4) We stopped at McDonalds right next to Walmart and went thru the drive thru. I must not have heard my cell phone go off, but the original Taxi cab who was suppose to pick me up, called and left a angry phone message on my cell phone stating " I just called you, and now you not taking the cab, whats wrong with you ". Yelling on the voice mail angrily. I thought the other cab driver that I was riding with had called American United to cancel out the cab. This came from the same phone number 414 - 335 - 3402.

5) After I arrived home, I went about my business, putting things away, and turned in for the night.

At 1:31am on 6 April, that night I heard my cell phone ringing, and it was coming from 414-335-3402. I thought what the heck is this guy calling me at this time of the hour, instead of just letting it go. I didn't answer it, and was upset that this guy would call me at that time. It must have been to harass me about not taking his cab.

6) At 1:32 am, he called again . His number was again from 414- 335 - 3402. I was getting really upset, and was going to call the Milwaukee Police because this guy was harassing me again. I immediately called American United at 1:33 am ,and the dispatcher put me thru to the voice mail of a woman who handles complaints. I stated on her voicemail, that if this cab driver calls me one more time again, that I was going to call the Police, and make a complaint to them, and that the Police was going to pick him up for harassment.

7) The next day I didn't receive a call back from the lady that handles the complaints, nor anyone from American United,

8) On 10 April, I still had not received a call back from American United, nor the Lady that handles the complaints, nor at any time I received a Voice mail from anyone at United American Taxi.

9) About a week later, I looked up the City of Milwaukee to see which department handles complaints about United American, and spoke to you. You informed me that I should put the complaint in a email to this address.

10) I've spoken to the lady who handles United Americans complaints previously before this incident, because a different cab driver over charges me for a ride on my credit card. I'm just wondering what the heck is going on with this cab company with the drivers that one one occasion charges my credit card too much, and another driver that calls me and harasses me. I think that my complaints aren't the only ones, and that the City of Milwaukee Common Council , and Licensing Department should look into this. I think that these cab drivers , and the lack of concern with United American not taking these issues seriously, should at Least be addressed. This Cab company, and drivers are starting to run amuk, and the only one that can control this is the Common Council and/or the Licensing Department.

11) I do not know the tag number of the two taxi cabs of that day, but only have a phone number of 414-335-3402.

Your name and e-mail address was listed as the manager which oversees alarm sales conducted by door-to-door sales representatives for the Vision Security Company located in Orem, UT.

The below complaint regarding Vision Sales Rep Bradley Collins was reported to me today by Mrs. Willie Bowen on behalf of Ms. Lucy Bowen.

Mrs. Willie Bowen advised me that Bradley Collins, while conducting door-to-door sales for Vision Security engaged her mother-in-law, Lucy Bowen at Ms. Bowen's residence, 2934 N. 26th St., Milwaukee, WI, on Saturday, August 11, 2012 in an effort to sell Ms. Bowen an alarm system. Ms. Bowen is 96 years old, suffers from alzheimers disease, and also experiences "tremors", shaking of her hands.

Bradley Collins proceeded to convince Ms. Bowen to purchase a Vision Security alarm system. According to Mrs. Willie Bowen, Bradley Collins forged Ms. Bowen's signature on the alarm system contract because Ms. Bowen is unable to sign due to her tremors. Ms. Bowen lives with her adult son caretaker who was not home at the time. Bradley Collins then proceeded to dismantle the current ADT system that Ms. Bowen has been using for the past 15 years and installed the Vision Security equipment.

Mrs. Willie Bowen feels that her mother-in-law was taken advantage of by Bradley Collins and is currently in contact with the Vision Security Customer Service Department, "Sean" and "Craig" in an effort to cancel the installation and contract. Mrs. Bowen contacted ADT to re-install the equipment that was dismantled by Bradley Collins. Mrs. Willie Bowen stated that ADT will charge her a fee for re-installing equipment that never should have been removed.

Back in May of this year I was notified by Milwaukee Police Department District Liaison Officer Shellee Lubus that she has received complaints of unethical sales practices regarding door-to-door sales reps claiming to be from "GE Vision." Officer Lubus stated that the complaints involve incidents of the reps being overly aggressive with the citizen who answers the door, asking personal questions, and using scare tactics in an effort to sell their system. Further investigation is being conducted to confirm whether the GE Vision sales reps are one and the same as the Vision Security reps.

The incident involving Ms. Lucy Bowen will be recorded and forwarded to the Milwaukee Police Department License Investigation Unit for possible Alarm Sales License revocation for the Vision Security Company.

Please remind the Vision Security sales reps that are currently selling alarm systems in Milwaukee the importance of proper and ethical sales practices.
