Re: Report on the Renewal Application of the Class "D" Operator's License of Cassandra A. Barbosa

**FINDINGS OF FACT**

1. Cassandra A. Barbosa (hereinafter the "Licensee") is the holder of a Class "D" Operator's License in the City and County of Milwaukee, Wisconsin. Said license expired on December 31, 2025.
2. An application to renew said license was thereafter filed with the Office of the City Clerk.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 11, 2025, the Milwaukee Police Department responded with a report that could form the basis for the suspension or nonrenewal of said licenses.
4. On January 14, 2026, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on January 27, 2026 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the Licensee did not appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:





- A. A notice of the hearing as well as a copy of the police report was sent to Cassandra A. Barbosa, 2181 North Burnham Street, Milwaukee, WI 53204 on January 14, 2026 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 2181 North Burnham Street, Milwaukee, WI 53204 is the address given by the Licensee on the application. The envelope was not returned to the License Division by the United States Postal Service.
- B. Alderman Burgelis moved denial based upon second nonappearance. There were no objections. (Prevailed 5-0)

### CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Cassandra A. Barbosa has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license based upon Licensee's second nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Operator's license held by Cassandra A. Barbosa based upon Licensee's second nonappearance.

### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of **five (5) ayes, and zero (0) noes** recommends that the Class "D" Operator's License of Cassandra A. Barbosa not be renewed based upon Licensee's second nonappearance.

On January 14, 2026, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. - B. Alderman Burgelis moved denial based upon second nonappearance. There were no objections. (Prevailed 5-0)

### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Scott M. Kalka has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license based upon Licensee's second nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Operator's license held by Scott M. Kalka based upon Licensee's second nonappearance.

### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of **five (5) ayes, and zero (0) noes** recommends that the Class "D" Operator's License of Scott M. Kalka not be renewed based upon Licensee's second nonappearance.

Re: Report of the Renewal Application of Sidian M. Flores Manzanares, Agent for ANTOJITOS CATRACHOS LLC, for a Food Dealer and Food Peddler licenses for a food truck and premises located at 1339 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("ANTOJITOS CATRACHOS").

**FINDINGS OF FACT**

1. Sidian M. Flores Manzanares (hereinafter the "Licensee") is the holder of a Food Dealer and Food Peddler license for a food truck premises located at 1339 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("ANTOJITOS CATRACHOS"). Said license expired at midnight, November 7, 2025.
2. An application to renew said license was filed with the Office of the City Clerk on September 26, 2025.
3. Pursuant to Chapters 68 and 90 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation. On September 26, 2025, the Milwaukee Police Department responded with a report that could form the basis for nonrenewal of said licenses.
4. On January 13, 2026, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68, 82, 84, and 85 of the Milwaukee Code of Ordinances of the neighborhood objections and included a copy. The matter was scheduled for a hearing on the police report and neighborhood objections on January 27, 2026 at 9:25 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the Licensee did not appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On February 4, 2025, the Licensee was cited by the Milwaukee Health Department for Food License Required. On April 24, 2025, they were found guilty and fined. Case #25010528.





- B. Alderman Burgelis moved denial based upon fourth nonappearance. There were no objections. (Prevailed 5-0)

### CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 68, 82, 84, and 85 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Sidian M. Flores Manzanares who holds a Food Dealer and Food Peddler licenses for a food truck and premises located at 1339 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("ANTOJITOS CATRACHOS ") has not met the criteria of Chapters 68, 82, 84, and 85, of the Milwaukee Code of Ordinances to renew the Food Dealer and Food Peddler licenses based upon fourth nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Food Dealer and Food Peddler licenses for the food truck and premises located at 1339 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("ANTOJITOS CATRACHOS ") based upon fourth nonappearance.

### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, including the Findings previously generated by the Committee in this matter, by a vote of **five (5) ayes and zero (0) noes**, recommends that the Food Dealer and Food Peddler licenses held by Sidian M. Flores Manzanares for the food truck and premises located at 1339 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("ANTOJITOS CATRACHOS") not be renewed based upon fourth nonappearance.
