WHEREAS, *When assigned Operator In Charge duties during a work shift, Francis Skalecki was a team leader, accountable for the functioning of the entire treatment plant and for the activities of the operations team; and*

WHEREAS, *Francis Skalecki richly and justly earned the enduring praise and gratitude of his family, friends, coworkers and the community at large for his dedication and service to the City of Milwaukee and the Milwaukee Water Works; and*

WHEREAS, *Francis Skalecki gained and displayed expertise through his work, performed with confidence and skill during his employment, meeting the challenges of his responsibilities as a Senior Water Treatment Plant Operator during his lengthy term of service to the City of Milwaukee and the Milwaukee Water Works; now, therefore, be it*
