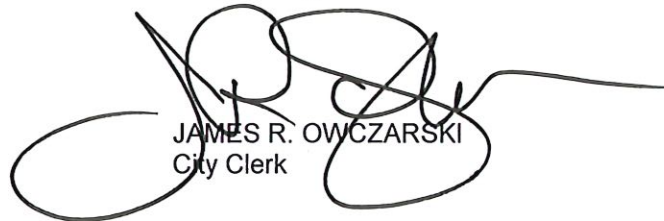
Dear Mrs. Antunez-Martinez and Mr. Antunez-Jimenez:

This is to notify you that on Tuesday, September 30, 2025, the City's Licenses Committee voted to recommend to the City's Common Council to renew your Food Peddler license with a 10 (ten) day suspension based upon the preponderance of the evidence in the Health Department and aldermanic testimony that demonstrates the operation results in a threat to the health, safety or welfare of the public for the failure to comply with the approved plan of operations; for the premises located at 4101 W GREENFIELD Av. ("EL PASTORCITO MIXE").

On October 02, 2025, you were mailed a true and correct copy of the findings of fact, conclusions of law, and recommendations of the Licenses Committee with respect to the Food Peddler license in which the Committee recommended renewal with a 10 (ten) day suspension of the Food Peddler license based upon the preponderance of the evidence in the Health Department and aldermanic testimony that demonstrates the operation results in a threat to the health, safety or welfare of the public for the failure to comply with the approved plan of operations. You were further notified that the Milwaukee Common Council would consider the matter at its meeting on Tuesday, October 14, 2025 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. You were advised of the right to file written objections and to appear personally or by counsel to address the Common Council. At that date, time, and place, you did not file written objections to the report of the Licenses Committee, you did not appear in person and you were not represented by counsel.

Following consideration of the report of the Licenses Committee, the Common Council voted renewal with a 10 (ten) day suspension of your Food Peddler license based upon the preponderance of the evidence in the Health Department and aldermanic testimony that demonstrates the operation results in a threat to the health, safety or welfare of the public for the failure to comply with the approved plan of operations. Said suspension is in effect between 12:01 a.m. on October 14, 2025 until 11:59 p.m. on October 23, 2025.

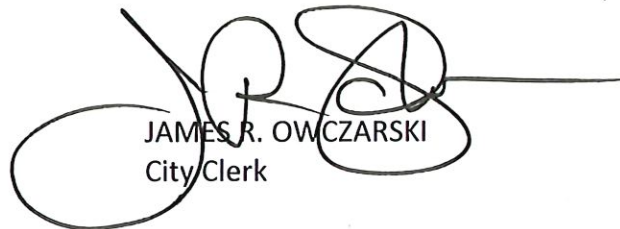

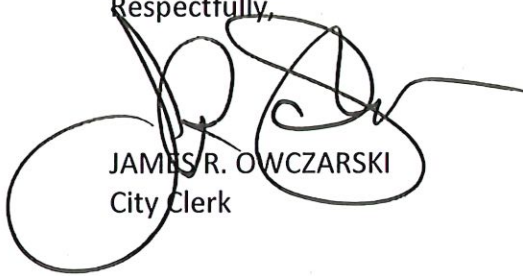
