A sister city, county, or state relationship is a broad-based, long-term partnership between two communities in two countries. A relationship is officially recognized after the highest elected or appointed official from both communities sign off on an agreement to become sister cities.

Milwaukee's Sister City Initiative



A city may have any number of sister cities, with community involvement ranging from a half dozen to hundreds of volunteers. In addition to volunteers, sister city organizations can include representatives from nonprofits, municipal governments, the private sector, and other civic organizations.

Each sister city organization is independent and pursues the activities and thematic areas that are important to them and their community including municipal, business, trade, educational, and cultural exchanges and projects with their sister city.

Our membership continues to increase and reflects the presence of over ten thousand African refugees and immigrants in the Milwaukee area (2009 Federal Immigration Statistics). MILAWA have membership of women from diverse backgrounds, involved in a vast continuum of professional and personal endeavors.

Our objectives to date have been to create an awareness of the attributes we bring to the Milwaukee community as women of African descent; to create and promote understanding among different cultures and societies within societies; to assist the integration of African immigrant/refugee women and their families as they transition in a new environment. Avocado is one of the most demanded crops in both the local and international markets. In this, farmers are now embracing the high value crop as they ditch less profitable crops such as maize and beans. According to statistics by the International Trade Center, Kenya is the largest exporter of avocados in Africa as of 2017 exporting approximately 51,507 tons of the fruit to the international market. Kenya has over 40 varieties of avocado. Hass is the main export variety and is preferred due to higher fat content than other varieties which gives it a richer taste while Fuertes is preferred for processing. Hass avocado variety is on demand in the international markets such as UAE, UK, Russia, and Spain with more than 70 per cent market share. (Source: FarmBizAfrica)

A Sister City agreement between Milwaukee and the County of Bomet, Kenya will be signed during a special ceremony next week in the third floor **Council Chamber and Anteroom at City Hall, 200 E. Wells St.** The ceremony will take place at **1:00 p.m. on Monday, November 23, 2015** and will be hosted by **Alderman Joe Davis, Sr.** and will feature Milwaukee **Mayor Tom Barrett** and **His Excellency Honorable Isaac Ruto**, Governor of the County of Bomet.

Alderman Davis, chair of the City of Milwaukee's Sister Cities Committee, said the **Sister Cities International** agreement with Bomet, Kenya has been in the works for several months, and has strong local support and interest. "It is clear that this important agreement will most certainly be mutually beneficial for the citizens of Milwaukee and the citizens of Bomet, and I would like to thank Governor Isaac Ruto for his support and work to help bring the agreement together," he said.


