Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Montreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/10/07 at 8:38 am, Milwaukee Police were dispatched to 3305 N Dr MLK Drive for an Entry complaint. Investigation revealed the business was broken into by someone who smashed the window and gain entry. The business was ransacked and items were missing per the owner, Isaac Ragsdale. A report was filed.
2. On 08/31/07 at 9:30 pm, Milwaukee Police conducted a license premise check at 3305 N Dr MKL Drive. Investigation revealed several patrons inside the Green Ring were drinking the alcohol that they had purchased earlier from the Green Ring. The owner, Isaac Ragsdale, was also under the influence, as officers could smell a malt beverage on his breath as he talked with officers. His speech was also slurred. Ragsdale received a citation for Permit Person to Tend Bar W/O License.

1. On 03/05/08 at 1:45 pm, Milwaukee police observed several subjects loitering in front of Green Ring II located at 3305 N MLK Drive. As police approached these subjects fled and ran into the Green Ring II store. Police proceeded inside and observed two open bottles of liquor, which were half full sitting on a counter in the rear of the store. Police also located another half full bottle behind some boxes near the front of the store. Officers attempted to speak with Isaac Ragsdale who refused to come from behind the counter. Ragsdale stated to police that he did not know what was going on. Police advised Ragsdale that subjects were not allowed to drink alcohol in the store with Ragsdale becoming uncooperative with police. Ragsdale stated he wasn't doing anything wrong and was tired of police messing with him.
2. On 03/07/08 at 3:30 pm, Milwaukee police along with an agent GeorgeAnn King conducted a license premise check at 3305 N MLK Drive. Agent King found the licensee, Isaac Ragsdale, did not have property receipts for purchases on alcohol and tobacco products. Agent King confiscated numerous alcohol and tobacco products. The applicant was issued a citation for Class A Retailer's Liquor License at 3305 N MLK Drive by Milwaukee police. A subject who found in the store to be in possession of marijuana was arrested and cited for same.

Police spoke to Isaac Ragsdale who stated he had his heat fixed and that he could be open. Investigation revealed inspectors had not been out to inspect the property and officers advised Ragsdale he needed to close until inspectors approved the work done.

- On 07/14/10, applicant was convicted of BAC in Milwaukee County. His license was suspended for 6 months.

4. On 04/15/10 at 10:00 pm, Milwaukee police observed several individuals loitering in front of Green Ring II Liquors where signs were posted with "No Loitering". As officers conducted field interviews, they could smell freshly burned marijuana. Some of the subjects were found to be in possession of marijuana. Officers also observed several of these subjects drinking from bottles of beer. All of these subjects were issued Loitering-Drug related citations. Officers also observed the owner Isaac Ragsdale by his pick-up truck parked in front of the store. Police observed a 24 Oz can of "Four Maxed 10% alcohol malt beverage on his truck bumper. When asked why Ragsdale didn't ask the subjects to leave and not loiter in front of his business, Ragsdale just shook his head from side to side. Ragsdale was informed that he would be issued citations as well.

5. On 02/19/11 at 9:40 pm, Milwaukee police were patrolling the area of 3300 N MLK Drive when police observed numerous individuals inside a closed business located at 3305 MLK Drive. Police attempted to enter the building but found the doors locked. Police announced themselves numerous times to which Isaac Ragsdale finally came to the front door and unlocked it. Police observed 13 individuals inside the business gathered around a television set, drinking beer and alcohol. Police advised Ragsdale that his class A license allowed only the sale of alcohol and that he needed a Class B license in order to serve and have patrons inside drinking. Ragsdale stated he understood and that it wouldn't happen again. Police escorted all patrons out and a report was filed.

- On 07/23/10, applicant was convicted of OWI in Racine County. His license was revoked for 9 months.

The owner Isaac Ragsdale was advised to removed the food items until he acquired the proper licensing. There was evidence of alcohol consumption on the premises. Multiple empty 50ml size bottles of alcoholic beverages were observed in the trashcan in front of the cashier counter along with (1) 750 ml empty liquor bottle. Officers also observed empty plastic cups with trivial amounts of an alcoholic beverage in them inside the trashcan. The state agents removed multiple boxes of tobacco products and bottles of liquor for tax regulation violations.

26. On 02/14/25 at 5:01p.m., Milwaukee Police were dispatched to a Shooting. Investigation revealed this took place outside of the business and had nothing to do with the store. The Agent provided a statement of what they witnessed and did call 911. They also provided video surveillance assisting officers with the investigation.

27. On 10/04/25, Milwaukee Police were assigned to work Wisconsin WINS, which checks area vendors for age compliant tobacco sales. At approximately 10:29a.m., a youth entered the business and purchased a tobacco product from the clerk who did not check ID. The clerk stated they did not need to check ID because they knew the youth was 18. The Agent was on scene and stated they thought the police had better things to do. The Agent was cited for Sale of Cigarettes to a Minor. Arraignment is scheduled for 01/20/26 Case # 25035117

28. On 11/24/25 at 12:52p.m., Milwaukee Police conducted a License Premise Check. Assisting in this assignment were Agents from Wisconsin Division of Alcohol; Office of Criminal Investigation and an Assistant District Attorney. On arrival officers observed a transaction of an alcohol beverage between the cashier and a customer. It was determined the cashier was the sole employee on scene and did not have a Class D Operator License. An Agent, checking a liquor box for distributor sticker observed a plastic bag in the box containing a green plant like substance, suspected marijuana.

An approved search warrant was then executed on the business. During the search warrant officers made the following observations:

- The business was filthy with dust on items and cooler doors not sealing properly
- Rat Poison located near tobacco items and water packs
- Old and expired food with layer of dust
- Areas of the floor that were sinking (referral to DNS and Health Department)
- Ceiling in the basement needed repair

- Liquor being stored in the basement

The officers recovered and confiscated the following items during the Search Warrant:

- Grinder, scale and WE Energies bill belonging to the Agent.
- 450 grams of THC
- 3 cigarillos containing 6.612 grams of THC
- 7 cherry Pie cigarillos; 9 Tango; 6 Pink Runts (w/o green sticker) weighing 39.00 grams
- Pink pill which tested positive for Methamphetamine (.34 grams)
- US Currency

This report is written by P.O. Brian HOLMES, assigned to District 5, early Power Shift, Squad 5261.

On Friday, February 14, 2025, at approximately 5:01 PM, I was dispatched to 3305 N Dr Martin Luther King Jr Dr. for a Shooting Complaint. This incident was a homicide.

Upon arrival I blocked traffic at the intersection of N Dr Martin Luther King Jr Dr and N Port Washington Rd. I then entered Green King II Liquor Store at 3305 N Dr Martin Luther King Jr Dr. to check for video surveillance of the incident. When I first arrived, the employee was not acknowledging my request to let me behind the counter to view the footage and I had to wait for the owner who verbally identified himself as Isaac T RAGSDALE (M/B 09/03/1971) to allow me behind the counter to view the video surveillance camera. RAGSDALE allowed me to view the incident on two of the cameras but the camera facing east on the front of the building was not operating at this time. The camera which would normally show the front counter area inside the building was also not mounted correctly.

Also added excerpts from other officers related to applicant's interview and video surveillance review.

Upon arrival I spoke to the owner of 3305 N. M.L.K. Jr Dr who was verbally identified as RAGSDALE, Isaac T., (B/M, 09/03/71). RAGSDALE stated he was inside of 3307 N. M.L.K. Jr Dr, when he heard one shot follow the victim with a gun in his hand. RAGSDALE stated he started screaming "MG MG LEAVE DUDE ALONE" thinking he was his other friend. RAGSDALE stated he then observed the suspect shoot the victim in the back of his head. RAGSDALE stated the suspect turned around attempting to run away and he then realized it wasn't his friend. RASDALE stated he ran away back to 3307 N. M.L.K. Jr Dr and locked the door behind him.

- RAGSDALE called 911.

I reviewed camera footage at 3305 N. M.L.K Dr which captured the entire footage of the incident.

On Saturday, 10-04-25, I along with coordinator Edgar Mendez from Jump at the Sun Consultants conducted a Wisconsin WINS Tobacco Prevention compliance check. Assisting were a 17-year-old female (TA' Niyah Shamon Sanders, B/F 07/05/08, 3514 N. 13th St.) and a 16-year-old male (Malik Hughes B/M 05/18/09, 2725 N. 11th St.). Both of them had a WI Id's Card that indicated their dates of births. Both are under the legal age to purchase a tobacco product.

They were instructed to walk into a business together and one of them would attempt to purchase a tobacco product. If the store employee asked for their ID card, they would present the employee with it. If the store employee did not ask for an ID Card, they would not present an ID Card. The legal age to purchase tobacco is 21 years old in the State of Wisconsin, 18 in Milwaukee.

At 10:29 AM., both Sanders and Hughes walked into Green Ring 2 located at 3305 N Martin Luther King DR. Hughes asked a cashier for a tobacco product and was served without them verifying his age.

This license premise report is written by PO David LETTEER, assigned to District 5 CPU, Sq. 5166.

On 11-24-25, I along with Special Agent Holly MCMANUS from Bureau of Enforcement Division of Alcohol Beverages, Special Agent Brian WALDHERR Office of Criminal Investigation and ADA Brittany KACHINGWAE went to the location of 3305 N. Martin L. King Jr. Dr., Green Ring II, which is a licensed business in Milwaukee.

Special Agent MCMANUS wanted to visit this establishment to conduct a liquor and tobacco inspection. Upon arrival the only person who was working was the clerk Tajirie J. DAVIS, who was sitting behind the cash register. DAVIS was informed of why we were at the establishment. DAVIS was able to contact the registered agent Isaac RAGSDALE, who eventually arrived at the business while we were there. As we entered the premise, a customer was standing in front of the cashier, holding what appeared to be money. Special Agent MCMANUS did later inform me that the two were going back and forth over the price of alcohol and a brown paper bag was observed.

I did check the licenses which were posted for Alcohol, food and cigarette. I did not see any license for DAVIS. I spoke to DAVIS and asked him if he had a Class D Operator's license and he stated he took the responsible servers course. DAVIS was informed to sell beer or alcohol he would need that a Class D Operator's license issued to him. A wanted check of DAVIS revealed a warrant for an unrelated incident and he was taken into custody and conveyed to District 5.

Special Agent MCMANUS began her inspection and behind the cashier counter, in the southeast corner of the building was a liquor box, which was inspected for the distributor sticker. Upon picking up the box, Special Agent MCMANUS found a black plastic bag in the box. When the bag was moved, she found that the bag contained a large clear plastic baggie containing a green plant like substance (suspected marijuana). Once this was found she stopped the inspection and drafted a search warrant for the premise.

The search warrant was drafted, reviewed and approved. Once the search warrant was approved, a copy was left with the business, eventually given to RAGSDALE. The search warrant encompassed the main floor of the business, as well as the basement area.

During the course of the search warrant located was a black wallet in the cashier area, with a small zip pouch containing a pink colored pill inside of the wallet, left at the store. There were 4 plastic jars of Black Kief Chiefs cigarillos, with one of the containers having a green sticker on the cap with \$5.00 written on the sticker, there were no other prices on the other 3 containers, located on a counter in the cashier area. The containers are from California Kief, Call exotic coating and advertised on the bottles THC-A/Hemp pre-roll 2 grams 20 count, being Delta 9.

The Black Kief's were in different flavor containers. There were two Pink Runts, with one being the container with the green sticker on the cap (3 cigarillos), Cherry Pie (7 cigarillos) and Tango flavor (9 cigarillos).

Also located was a black digital scale located in a Chor boi box, a gold in color metal grinder behind the cashier counter and a We Energies utility bill with the name of Isaac RAGSDALE, for the location of 3305 N. Martin L. King Jr. Dr.

During the course of the search warrant, officers found the establishment to be filthy, with dust on the liquor bottles, dust on beer cans in the cooler, cooler doors not sealing properly and rat poison next to tobacco items and flavored water packs. There was a small crock pot with what appeared to be a sauce cooking, but there was no food or any item there that day that would require sauce. The shelves where the food items were heavily covered in dust. Also found was a sealed food container on the top shelf of a food rack holding food items. It is unknown how old the sealed food container was. The container could not be seen until I used a ladder to look on the top shelf.

RAGSDALE had ammunition behind the counter and a BB pistol near the cash register, no firearm was located at the time of the search. There was old food on top of a shelf, along with chips in a box on top of a cooler, with a large layer of dust on the boxes, which appeared to be there for later sale.

While walking in the store, there were areas of the floor that when walked or one stood on began to sink, indicating that the floor is weak in certain spots. Upon going down into the basement, RAGSDALE was storing liquor items in a room, which did have the Green Ring label on the boxes.

Looking at the ceiling in the basement, there were spots that were broken and appeared to be broken from the main level down into the basement. The Health Department and DNS will be advised of this.

Special Agent MCMANUS did confiscate US Currency from the business, while Special Agent WALDHERR confiscated two boxes of Tobacco items, with two packs of cigarettes having the tax stamp scratched off. It was noted on their report that the business is much unorganized with the business documents. It is impossible to tell what the documents cover as it relates to the business. RAGSDALE was informed to update his license to include the basement being used for storage of his alcohol. It was also noted that RAGSDALE needs to keep two years' worth of invoices on premise for all cigarette and tobacco products, sorting his invoices by distributor.

The grinder, scale and We Energies bill were taken to District 5 and placed on inventory. The green plant like substance in the clear plastic bag was tested and tested positive for THC and placed on inventory. The 3 cigarillos in the Black Kief Chiefs Pink Runts container, with the green \$5.00 label on the cap was tested and that also returned positive for THC. It should be noted that the cigarillos from all the containers were rolled the same with the fat end, which would be burned upon using a lighter, had a pressed in end.

The exception would be the container with the green \$5.00 sticker that the 3 cigarillos contained in the container had the fat end, which would be burned did not have pressed in end, but was wrapped in a pigtail, which indicated that these cigarillos might be rolled by someone other than the manufacturer.

The total amount of items recovered during the State's search warrant is:

- 450 grams of marijuana (THC)
- The 3 cigarillos in the green sticker \$5.00 bottle had a total weight of 6.612 grams of marijuana

- The 7 Cherry Pie cigarillos, 9 Tango cigarillos and 6 Pink Runts (without the green sticker) weighed 39.00 grams gross weight
- Pink pill in the zip pouch tested positive for Methamphetamine and weighed .34 grams and US Currency

A check of the application does not show the basement being applied for as it relates to the storage of alcohol and the license is for the entire first floor.


