Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. **Notice for applicants with warrants or unpaid fines:**

**Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.**

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is written by Police Officer KUKOWSKI, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/27/2014 at the Days Inn at 1840 N. 6<sup>th</sup> St, four unknown actors, all armed with firearms, forced their way into the victim's hotel room by pushing past the victim after knocking. The suspects obtained property and fled the scene. The applicant was informed of this incident and was very cooperative with officer.
2. On 01/04/2015 at 12:21am officers responded to the Days Inn at 1840 N. 6<sup>th</sup> St for a Shooting. The investigation revealed the victim had rented a room for a party. There was alcohol and gambling at the party. During the party, unknown black male subjects, armed with guns arrived and attempted to rob the party patrons. The victim was shot through the door of the room. The officers on scene were unable to access or copy the security footage due to the applicant being out of the country and the employees not having access to the system.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.



Once inside the open business I interviewed the clerk/cashier Janice V WILLIAMS (b/f, 07/22/72) who was standing behind the enclosed glass partition. WILLIAMS along with a middle eastern male identified as Darwish THABATA (a/m, 6/5/65) who did not speak any English were the only two employees on the premises. WILLIAMS confirmed that "Zak's" was open for business and that the owner "MO" was available by telephone. WILLIAMS contacted MO identifeied as Muawia AL BAWANEH (a/m, 12/29/91), AL BAWANEH stated that he was advised by the Health Department two days ago that it was "ok" to continue the business with the name changed to Zak's using the prior agent Mohammad SALEEM'S license and occupancy permit until it expires on 6/30/17. I P.O RUEDA advised AL BAWANEH that he could not continue to use SALEEM'S license and occupancy permit to run ZAK'S and that he needed his own license and permits to operate his business. AL BAWANEH stated he understood and would take care of it immediately . On Wednesday, April 26<sup>th</sup> I checked LIRA (License Information Reporting and Administration System) for information regarding AL BAWANEH applying for his license and did not find an application. On Wednesday, April 26, 2017 at about 1:30pm my partner P.O. Penny BROWN and I returned to Zak's at which time we observed the clerk WILLIAMS behind the counter with the store open for business. WILLIAMS contacted AL BAWANEH who arrived on scene shortly thereafter. AL BAWANEH was again advised that he could not operate his business "ZAKS" without a Food Dealer License. AL BAWANEH stated that he would have his license in three days.

This report is written by P.O. Ryan MAXCEY, assigned to District 5, late shift.

On Wednesday October 4, 2015 at 12:34 AM, while assigned to squad 5321 (P.O. HUMITZ and I) were dispatched to Midnighter's Bar located at 3038 N Teutonia Av to look for a subject with gun. We were sent to look for Clarence POE who was said to have a gun behind the bar. We arrived at the location and there was loud music coming from the bar, there were lights on inside of the bar and there were five people in the bar. One person was sitting at the bar operating a sound system, three people playing pool and one standing in the back of the bar. We asked each of the people if they were the bartender or worked at the bar and everyone stated they did not.

P.O. HUMITZ and I went through an open back door and went up a hallway to see if we could locate the bartender or the subject. No one at the bar would admit to working there. Operating as a community caretaker, we entered the residence to make sure everything was all right and attempted to make contact with any subjects that may be there. We felt that a bartender may be in the upper or lower level as that was the only area of the building we did not check and the bar was open. We announced ourselves as Milwaukee Police and went into an open door on the upper level. While conducting a sweep of the upstairs we came upon a bedroom with an open door. Inside of the bedroom in plain sight were several small baggies of suspected marijuana (later tested positive for THC - 17.8 grams) sitting on a table. Also in plain sight were three plastic gun cases. Inside of the bedroom we also found five small scales near the suspected drugs.

On a table next to the drugs was a Wisconsin Department of Transportation letter addressed to Clarence I POE Jr with an address for the location. There were also two prescription pill bottles with Clarence I POE's name on them.

We came downstairs to alert the other officers as to what we had found and when we attempted to go back upstairs, Tawanna S MCCOY (B/F, 03/15/82) attempted to stop us from gaining entrance to the upstairs. MCCOY was asked to go sit at the bar. After repeatedly asking and MCCOY continuing to not sit down but yell at us and attempt to get past us she was put in handcuffs and a municipal ticket was written for resisting our investigation.

Mary A. ANDERSON (B/F, 05/05/61) came to the premises and told us that she was the owner of the building but not the bar. ANDERSON stated that the bar does not have a license right now and is not suppose to be open. ANDERSON stated that she hired some people to do repairs on the bar, and that they would often work late because they had day jobs. She said that the only people who currently have keys are her son (POE) and the workers and she is unsure who opened the bar for service tonight. We checked the Tavern license but it had expired on 5/4/15.

According to ANDERSON the business is not open and is under construction in an attempt to reopen. ANDERSON owned the building but was not running a tavern. That night we could find no one who admitted to being a bartender, we never saw anyone served alcoholic beverages. ANDERSON felt that either her son or the workers she had hired were running the bar, but she had no firsthand knowledge of this she only suspected them because they had keys to the bar.

The suspected marijuana, baggies, scales and gun cases were taken as evidence.

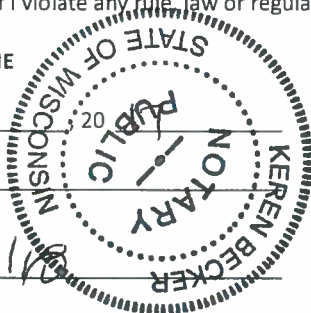
