



RE: CLUB 69 TAVERN

The undersigned, Ana Baez, a resident of the City of Milwaukee, Milwaukee County, Wisconsin, hereby complains as follows:

- 1.) Club 69 Tavern is located at 1669 S. 11th Street in the City and County of Milwaukee and is directly across the street from the residential building where I reside located at 1670 S. 11th Street.
- 2.) Club 69 has consistently been a source of disruption, disorder, and unease in the community. As such, Club 69's request for renewal of its liquor license should be denied.
- 3.) I have lived at 1670 S. 11th Street for the past ten (10) years. My phone number is 414-861-7401.
- 4.) I am also a high school counselor at South Division High School, and I was named the 2025 Wisconsin Teacher of the Year.
- 5.) As a longtime resident and community member who works and lives in the area, I care deeply about the safety, well-being, and quality of life of the people in the neighborhood.
- 6.) Club 69's negative impact on the community is significant and ongoing. On most nights—including weekdays—excessively loud music plays into the early hours of the morning, often made worse when the establishment props its doors open. This noise alone is disruptive, but it is routinely accompanied by loud screaming, altercations, and fights among the club's patrons that spill out into the street, disturbing families, children, and elderly residents alike.
- 7.) This is not limited to isolated weekends—it is a recurring issue, particularly during warmer months. The safety of our building's residents is further compromised when street and parking access is blocked due to police activity stemming from incidents at the bar.
- 8.) Recently, there was a fatal shooting that occurred just outside the establishment. I looked out my window to a crime scene filled with yellow cones marking bullet casings, blood on the street, news crews, and flashing emergency lights. This is not the first time gun violence has occurred in connection to the bar. On multiple occasions, shots have been

fired into the air late at night, frightening the entire block. I personally have made calls to 911 regarding gun violence and fights.

9.) There are hard-working families, children, and elderly residents in our building, all of whom deserve peaceful nights and the right to feel safe in their own homes. Club 69 has repeatedly demonstrated an inability—or unwillingness—to operate responsibly.

10.) Club 69 contributes nothing positive to the community. Instead, it has become a serious public safety concern and a burden on the residents of this neighborhood.

THEREFORE, your complainant respectfully urges you to **deny the renewal of the liquor license for Club 69**. The health and safety of our community must take precedence over the interests of an establishment that has consistently put us at risk.





The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/04/24 at 1:59p.m., Milwaukee Police were dispatched to a Trouble with Subject at 1663 S. 11th St. Investigation revealed the agent was in the hospital and had an agreement with the owner, they would cease operation, until they were able to pay the rent owed, however, another subject was on scene and operating the business. The owner of the building and the agent confirmed the business should not be operating and the subject had no affiliation or authorization to operate. The subject left on police request and the owner changed the locks on the door.

The following items pertain to the business at 1663 S. 11th St.

2. On 06/23/25 at 9:00a.m., Milwaukee Police conducted follow up in regards to a Reckless Endangering Safety, that occurred at 1:20a.m. A witness advised officers, they were awakened by 30+ automatic/rapid gunshots, followed by more. The witness stated they observed subjects exit the business, appearing to pick up casings, one was armed with a firearm with a drum style magazine. A second witness approached and stated there has been a lot of trouble at the business, suspected drug traffic and patrons harassing tenants. The witness further noted a homicide that occurred on 06/04/25 to the north of the bar. The investigating officers recovered 30+ assorted casings. No one from the business called the police regarding the incident and the bartender told the officers the cameras didn't work.

3. On 06/23/25 at 7:50p.m., Milwaukee Police conducted follow up regarding Incident 2. An employee who refused to provide their title, pointed out video surveillance cameras to officers and stated one in the windowsill pointed to the exterior, however, there were no exterior cameras. The employee stated the exterior pointing camera was inoperable due to it not having an SD card. Officers observed 3 Hookah Pipes; Tobacco Products; disco/laser lights and multiple gaming/gambling machines. A check of the business application showed the boxes were not checked to allow for entertainment machines/equipment and specifically stated there were no designated smoking areas.
4. On 06/24/25 at 9:00a.m., Milwaukee Police conducted follow up regarding Item #2. A citizen witness provided video of subjects exiting the business and presumably checking for casings. One of the subjects was seen tucking an object into their shorts and doing "security checks", a behavior consistent with concealing a firearm. The video was uploaded to Evidence.com.
5. On 07/16/25 at 9:34p.m., Milwaukee Police conducted a License Premise Check. Assisting in this assignment was an Agent from Wisconsin Department of Revenue Alcohol and Tobacco. On arrival officers observed the front door open, with lights and music and Hookah and tobacco products. It was determined that no employees on scene, including the manager did not have a bartender license or a manager license. The Agent arrived on scene and stated they weren't aware they had to be at the location in order to operate and was unable to provide any invoices for liquor purchases, but stated they buy beer and liquor from local liquor stores. The business does not have a Tobacco license; therefore, tobacco product was confiscated as well as liquor. The Agent was issued the following citations:

6. On 07/23/25 at 9:49p.m., Milwaukee Police conducted a License Premise Check. The Agent was on scene as well as a security guard wanding patrons as they entered. No violations were found.

This report is written by PO Matthew DIENER, assigned to District 2, day shift, squad 2166. On Tuesday, June 24, 2025 at about 9:00am I contacted Alex KOSTNER, the property manager for 1670 S 11th St, who left a message stating that he received further video evidence that showed one the parties involved with the RES from 6/23/25 at 1:20am. Alex stated that one of his tenants came forward, and text him video that collaborated with a previous witnesses account, the tenant was interviewed by myself on 6/23/25. The video did not come from the tenant, but matched the tenant's eyewitness account.

The video does not have a time stamp, but shows 2 hispanic males exiting Club 69, 1663 S 11th St, with one male (SUS 1), wearing a backward tan baseball hat, white t-shirt, black shorts, and tan and black tennis shoes walking around to the driver's side of a white Jeep Wrangler SUV, and is tucking an object into his shorts, making several "security checks" which is a behavior consistent with subjects concealing a firearm. Two more subjects are then seen exiting, SUS 2 is a Hispanic male wearing a white t-shirt, black baseball hat, and black fanny-pack. SUS 3 is wearing a white baseball hat, white t-shirt, black shorts, and sandals.

SUS 1 then pulls out his cellphone and turns on his flashlight, pointing it at the ground, presumably looking for spent casings, right outside of Club 69. SUS 4 then exits the bar, described as a Hispanic male, wearing a tan t-shirt, jean shorts, and tennis shoes, holding a bottle of beer. SUS's 2,4, and 4 all then walk south towards a red sedan, enter, and drive south on S 11th St and then west on W Mitchell St. Moments later you observe SUS 1 drive off in the white Jeep Wrangler SUV, taking the same route and the red sedan. The video was uploaded to Evidence.com.

This report is written by Sergeant Daniel STACHOVIK, assigned to District Two, Late Power Shift.

On Monday, June 23, 2025, at approximately 7:50 PM, myself, along with Squad 2471 (Officer Justin MERRITT and Officer Daniel FINN) responded to the **Club 69** tavern located at **1663 South 11th Street** to conduct follow up regarding a Shots Fired RES that occurred in front of the location on June 23, 2025, at approximately 1:20 AM.

Upon arrival to the location the front door was closed but unlocked. Upon entry to the location I observed one male subject who identified himself as Rafael J. ARCE-HERNANDEZ (H/M, 6-24-74). ARCE-HERNANDEZ stated that he arrived at the location at approximately 6:30 PM. He stated that he was at the location to clean the tavern, but refused to provide a title for his employment. He stated that he was not a bartender or a bar back. He stated that he only cleaned the location and stocked the coolers.

ARCE-HERNANDEZ began pointing out the cameras at the location. When asked about the exterior camera, he showed a "WYZE Cam V2" that was positioned on the window sill positioned to view the exterior of the location. There were no cameras affixed to the exterior of the building. ARCE-HERNANDEZ then showed the interior cameras for the location. (3) Three interior mounted cameras were "WYZE" cameras (2 were behind the bar, 1 was positioned on the southwest corner of the tavern area). Additionally, I observed a "Blink" camera on top of the cash register and an additional one mounted and facing the possible bottle service area. This area is blocked off with a half wall and contains two couches, two small square tables, and a large screen TV.

ARCE-HERNANDEZ stated that he did not have access to the video cameras, but stated that the "Owner", Jose LOPEZ, should be able to access the recordings. He reported that the camera that is positioned to view the exterior of the building does not record. He stated that an incident occurred two weeks prior and Milwaukee Police Detectives took the SD card that had been in the device. He stated that the camera has not recorded since. The interior cameras appeared to be operating and functional during this License Premise Investigation.

During the investigation I observed (3) three Hookah Tobacco smoking pipes on top of the back bar along with tobacco products. I observed a sound bar equalizer on the back bar and a large speaker on the floor, next to the sound bar. Also located in the tavern were disco and laser lights mounted to the ceiling.

Additionally, I observed (4) four gambling style games/machines as well as a "Pull Tab" game that were all plugged in and operational.

A check under the City of Milwaukee License Search revealed that Club 69 is only issued a Class B Tavern License, which expires on March 3rd, 2026. The renewal application does not have any boxes checked for their entertainment machines or other entertainment equipment (Lighting/Music). Additionally, the renewal license specifically stated that there are no designated smoking areas inside or outside of the location.

Squad 2423 (Officer Shemar MOORE and Officer Roberto GAMINO) responded to the location later in the evening in an attempt to speak with the owner. Please refer to their supplemental report regarding the follow up investigation.

Alex stated that one of his tenants came forward, and text him video that collaborated with a previous witnesses account, the tenant was interviewed by myself on 6/23/25. The video did not come from the tenant, but matched the tenant's eyewitness account.

The video does not have a time stamp, but shows 2 hispanic males exiting Club 69, 1663 S 11th St, with one male (SUS 1), wearing a backward tan baseball hat, white t-shirt, black shorts, and tan and black tennis shoes walking around to the driver's side of a white Jeep Wrangler SUV, and is tucking an object into his shorts, making several "security checks" which is a behavior consistent with subjects concealing a firearm. Two more subjects are then seen exiting, SUS 2 is a Hispanic male wearing a white t-shirt, black baseball hat, and black fanny-pack. SUS 3 is wearing a white baseball hat, white t-shirt, black shorts, and sandals.

SUS 1 then pulls out his cellphone and turns on his flashlight, pointing it at the ground, presumably looking for spent casings, right outside of Club 69. SUS 4 then exits the bar, described as a Hispanic male, wearing a tan t-shirt, jean shorts, and tennis shoes, holding a bottle of beer. SUS's 2,4, and 4 all then walk south towards a red sedan, enter, and drive south on S 11th St and then west on W Mitchell St. Moments later you observe SUS 1 drive off in the white Jeep Wrangler SUV, taking the same route and the red sedan. The video was uploaded to Evidence.com.

PO MUNOZ issued citation a citation to PINERO LOPEZ regarding.

While checking the location officers observed hookahs and tobacco product at the bar. The tobacco and hookahs were photographed on scene. The tobacco product was collected and inventoried as evidence under case#C2507160179. I took 12 digitals photos on scene; the photos were uploaded to Evidence.com under call#P2507161570. The establishment does not have a valid tobacco license. When asked about the Tobacco products, LOPEZ SAAVEDRA claimed they do not sell any of the product.

While on scene Special Agent Ashley SCHNERING confiscated all liquor from the location. Special Agent Ashley SCHNERING did not confiscate the beer at the location.
