FINDINGS OF FACT

- 1. Linda M. Cimbron (hereinafter the "Licensee") is the holder of Food Dealer and Weights & Measures licenses for the premises located at 1316 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("CVS Pharmacy #8762"). Said licenses expired at midnight, February 23, 2019.
- An application to renew said licenses was filed with the Office of the City Clerk on 2. March 11, 2019.
- Pursuant to Chapters 68, 82 and 85 of the Milwaukee Code of Ordinances, the matter was 3. referred to the Milwaukee Police Department for investigation.
- On March 22, 2019, the City Clerk's Office provided notice to the Licensee pursuant to 4. Chapters 68, 82 and 85 of the Milwaukee Code of Ordinances of the police report and neighborhood objections and included a copy of the police report. The matter was scheduled for a hearing on the police report and neighborhood objections on April 3, 2019 at 9:00 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee did not appear.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

CONCLUSIONS OF LAW



- The Committee has jurisdiction to hold hearings and provided Findings of Fact and 1. Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapters 68, 82 and 85 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Linda M. Cimbron who holds Food Dealer and Weights & Measures licenses for the premise located at 1316 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("CVS Pharmacy #8762") has not met the criteria of Chapters 68, 82 and 85, of the Milwaukee Code of Ordinances to not renew the Food Dealer and Weights & Measures licenses. The Committee finds the health department reports and aldermanic objections as stated above to be true. The Committee based its recommendation on the Licensee's nonappearance.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Food Dealer and Weights & Measures licenses for the premises located at 1316 West Forest Home Avenue in the City and County of Milwaukee, Wisconsin ("CVS Pharmacy #8762"). The Committee based its recommendation on the Licensee's nonappearance.

RECOMMENDATION

- 1. Parul D. Patel (hereinafter the "Licensee") is the holder of a Class "A" Malt and Class "A" Liquor licenses for the premises located at 3447 West Wells Street in the City and County of Milwaukee, Wisconsin ("Sundeep Liquor & Food"). Said licenses expire at midnight, May 2, 2019.
- 2. An application to renew said license was filed with the Office of the City Clerk on February 7, 2019.
- 3. Pursuant to Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation.
- 4. On March 21, 2019, the City Clerk's Office provided notice to the Licensee pursuant to Chapters 68, 85 and 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report and neighborhood objections. The matter was scheduled for a hearing on the police report and neighborhood objections on April 3, 2019 at 10:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, Deven Patel, husband of Licensee, appeared with counsel Attorney Vincent Bobot, at the hearing and admitted receipt of the notice of hearing.
- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On March 5, 2018, officers conducted a license premise check at Sundeep Liquor, 3447 West Wells Street. The sole employee was identified as Obika OKWUDIRI, and he was able to produce the business licensee but did not have a Class D Operators license. The manager, Devin Patel, stated he was running



errands and another employee with a Class D license should be here. Patel advised the store would close until a license person arrived on scene. The applicant was cited for Responsible Person on Premise.

Case:

- В. On May 19, 2018, a 17 year old working in conduction with the Milwaukee Police Department and "Wisconsin WINS" Tobacco Initiative, was able to purchase a Spiked Lemonade Cigar from the clerk at Sundeep Liquor, 3447 West Wells Street. The clerk did check his ID but made the sale anyways. The clerk was identified as Harish MEHTA and he stated he thought the ID showed the juvenile was over 18. The applicant was mailed a MARTS enrollment package.
- C. On July 19, 2018, officers conducted a licensed premise inspection on 3447 West Wells Street. The officers questioned Devin Patel about transferring liquor between two of his businesses. After repeatedly stating he did not do that, then he was shown photos of himself taking liquor from his trunk and he did admit to transferring between stores. He was cited for Obstructing an Officer.
- D. On July 28, 2018, officers observed several people sitting along the wall of the store at 3447 West Wells Street, public drinking. Most of the subjects left when they saw the officers. One subject stayed and was so intoxicated he needed to be conveyed to Detox. The officers attempted to speak with the employees of the store, who stayed behind the glass partition, but were informed the agent was not on scene at this time.
- E. Attorney Bobot said his client passed all 4 MARTS inspections and made proof of that part of the record. His clients have removed items conducive to loitering and they are now picking up litter daily, although they may need to increase that. His client does photograph individuals who loiter and he denies service to them. This business has operated for eight years at this location.
- F. Alderman Witkowski made the information on passing MARTS part of the record. Exhibit 1.

Individuals in Opposition:

Douglas Burna, 731 N. 34th St., he is tired of the loitering, panhandling, litter and G. the trash, which has only gotten worse over time. He would like this store gone; 90% of the time when he goes past there is something going on litter on the premises, public drinking, and litter from the store on in the area. He indicated that he lives near the location and drives past the premise on a near daily basis.



- H. Karen Burns 3130 W. Wells St., there is always a crowd outside up until the time of closure. She has been approached by panhandlers, and in inconvenienced by double parking. She finds a lot of small liquor bottles on her corner property and can often see that they are coming from this store. She has observed people coming from the store and drinking, and loitering on her front steps and publicly consuming alcohol.
- I. Laura Sue Moser 3209 W. Wells St., the photos are already in the file. She operates a bed and breakfast near the store. She testified that her business has lost customers as they drive past 35th and Wells, due to the perception that the neighborhood is unsafe because of people loitering. Panhandlers approach their guests as they are getting out of their cars, she observes public urination, arguing, and unsafe actions due to drinking. She noted that she knows much of the litter is coming from the store because she observes small bottles of hard liquor, and the other store in the area only sells beer. This liquor store is destroying what she is working on and feeds into the negative rather than the positive.
- J. Rick Moser, 3209 W. Wells St, he agrees with his wife and he is surprised no one has ever been killed at 35th and Wells due to the parking and he sees the proliferation of liquor bottles in yards.
- K. Dwayne Stokes works with Near West Side Partners. He is a security ambassador in the community. They have seen mobile drug dealing from across the street to his building. He testified that people from Near West Side partners have gone into the store and asked the employees to try to help scatter the loiterers. They will wait and not observe any employees come outside to try to disperse patrons they tell him people are loitering outside, they wait 10 minutes and nothing is done. The store also fails to maintain the cleanliness of the surrounding area."
- L. Botney Macque community safety specialist for Near West Side Partners, he has spent a lot of time working with the police on the complaints about this establishment. In the hot months, there are always folks loitering by this establishment. They have reached out, but the owners have never responded.
- M. Keith Stanley, the Executive Director of the Near West Side Partners testified that the organization's concern is that this establishment is not proactive. People from the neighborhood and the organization has stopped at the business and left contact information for someone from the store to contact them, and have not gotten a response. He also noted that this reflects negatively on the district as this is the only area zoned for a bed and breakfast in Milwaukee. This is the front door to the Concordia neighborhood.
- N. Ted Cusick 7227 N. 32nd St., he is a recovering addict and in the past he used this facility to get money by panhandling. Mr. Cusick testified that he is now sober and works at the Moser's bed and breakfast. He explained that what the other



- people have testified about is behavior he has observed while working. He stated that he now understands how destructive this behavior is. He conceded that the Licensee would come and ask him to move when he was panhandling, but he would not go very far and would remain in the neighborhood.
- The Licensee testified that when he sees loiterers he tells them to leave; O. sometimes they do and sometimes they refuse. He does not serve those who loiter in front of the premises. He has banned a number of patrons from the location. He is cooperative with the bike patrol officers and MPD generally. He allows the police access to a vacant area on his second floor to observe. He works there all the time and tries to control everybody. They sell liquor, chips, soda, tobacco and bus passes. He is willing to fully cooperate with the neighborhood, hire private security, re-double his anti-litter effects and cooperate with the police. He testified that he is at the location from 9:00 a.m. to 9:00 p.m. almost every day.

Patel who holds a Class "A" Malt and Class "A" Liquor license for the premise located at 3447 West Wells Street in the City and County of Milwaukee, Wisconsin ("Sundeep Liquor & Food") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances not to renew the Class "A" Malt and Class "A" Liquor licenses. The Committee finds the neighborhood and aldermanic objections as stated above to be true. The Committee based the nonrenewal on the police report, neighborhood testimony and aldermanic testimony.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment not to renew the Class "A" Malt and Class "A" Liquor licenses for the premises located at 3447 West Wells Street in the City and County of Milwaukee, Wisconsin ("Sundeep Liquor & Food"). The Committee based its recommendation on the police report, neighborhood and aldermanic testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) aves and one (1) noes recommends that the Class "A" Malt and Class "A" Liquor

People from the neighborhood and the organization has stopped at the business and left contact information for someone from the store to contact them, and have not gotten a response. He also noted that this reflects negatively on the district as this is the only area zoned for a bed and breakfast in Milwaukee. This is the front door to the Concordia neighborhood.
- N. Ted Cusick 7227 N. 32nd St., he is a recovering addict and in the past he used this facility to get money by panhandling. Mr. Cusick testified that he is now sober and works at the Moser's bed and breakfast. He explained that what the other



- people have testified about is behavior he has observed while working. He stated that he now understands how destructive this behavior is. He conceded that the Licensee would come and ask him to move when he was panhandling, but he would not go very far and would remain in the neighborhood.
- O. The Licensee testified that when he sees loiterers he tells them to leave: sometimes they do and sometimes they refuse. He does not serve those who loiter in front of the premises. He has banned a number of patrons from the location. He is cooperative with the bike patrol officers and MPD generally. He allows the police access to a vacant area on his second floor to observe. He works there all the time and tries to control everybody. They sell liquor, chips, soda, tobacco and bus passes. He is willing to fully cooperate with the neighborhood, hire private security, re-double his anti-litter effects and cooperate with the police. He testified that he is at the location from 9:00 a.m. to 9:00 p.m. almost every day.
- P. Alderman Witkowski moves for nonrenewal based on police report and neighborhood and aldermanic testimony, (Prevailed 4-1)

CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 68, 85, and 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the Licensee, Parul D. Patel who holds a Class "A" Malt and Class "A" Liquor license for the premise located at 3447 West Wells Street in the City and County of Milwaukee, Wisconsin ("Sundeep Liquor & Food") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances not to renew the Class "A" Malt and Class "A" Liquor licenses. The Committee finds the neighborhood and aldermanic objections as stated above to be true. The Committee based the nonrenewal on the police report, neighborhood testimony and aldermanic testimony.
- 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment not to renew the Class "A" Malt and Class "A" Liquor licenses for the premises located at 3447 West Wells Street in the City and County of Milwaukee, Wisconsin ("Sundeep Liquor & Food"). The Committee based its recommendation on the police report, neighborhood and aldermanic testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) noes recommends that the Class "A" Malt and Class "A" Liquor



licenses held by Parul D. Patel for the premises located at 3447 West Wells Street in the City and County of Milwaukee, Wisconsin ("Sundeep Liquor & Food") not to be renewed.

Said nonrenewal will be in effect at 12:01 a.m. on May 3, 2019.
