Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

This report is written by Police Officer Carlos Felix, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 04/10/24 at 8:30a.m., Milwaukee Police were dispatched to a Threat at 1202 W. Highland. Investigation revealed security asked a subject to leave the property and they made a threat to come back and shoot the security officer. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
2. On 07/12/24 at 1:00p.m., Milwaukee Police took a walk-in complaint from a citizen that occurred at 1202 W. Highland. Investigation revealed on 07/12/24 at 1:45a.m., the citizen walked into the business to make a purchase and had a handgun in their pocket. The citizen left, however, remembered they left an item on the counter and returned without their firearm. A security guard then pulled out their firearm and pointed it at the citizen. The officer conducted follow up to identify the security officer, however, they were not on scene and were unable to contact a supervisor of the security company.
3. On 07/31/24 at 2:28a.m., Milwaukee Police were dispatched to a Subject with Weapon at 1202 W. Highland Ave. Investigation revealed a suspect was confronted by security regarding an attempt theft. The suspect made a threat to "pop" the security guard. Once outside the security guard observed the suspect was armed and ordered them to drop their gun. The suspect then left the scene. The business was cooperative and allowed officers to view video surveillance, however, due to technical difficulties, it was never entered into evidence.com.

4. On 09/02/24 at 6:57a.m., Milwaukee Police were dispatched to a Threat at 1202 W. Highland. Investigation revealed security asked a subject to leave and an altercation took place. The subject threw a cup of coffee at security at which time the security officer strikes the subjects car with their baton, causing the subject to kick the security officer's bumper. The subject then fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
5. On 11/06/24 at 3:22a.m., Milwaukee Police were dispatched to a Reckless Endangering Safety at 1202 W. Highland. Investigation revealed a subject was told to leave due to smoking in the store. The suspect returned with a firearm and fired several shots at the window where the victim was standing. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

The following items are related to Pantry 41 located at 1202 W. Highland Ave.

6. On 01/12/25, at 4:37 p.m., officers were dispatched to a Subject with Weapon complaint. A security guard employed by the business approached a vehicle near a gas pump, and pointed what the caller believed to be a long gun at them. After reviewing security camera footage, the guard was taken into custody for disorderly conduct. The long gun was found to be a facsimile weapon.
7. On 01/19/25, at 11:02 a.m., officers were dispatched to a Theft complaint. A customer threw a cup of coffee on the floor after becoming upset over the price. An employee locked that customer in the business but let them go after they started smoking. No additional police service was needed.
8. On 07/04/25, at 6:10 p.m., officers were dispatched to a Retail Theft. An employee locked a subject in the business after they opened a beverage, drank it, and refused to pay. The subject was gone prior to officers' arrival, so additional police services were not needed.
9. On 07/22/25, at 12:14 a.m., Officers were dispatched to a Theft complaint. An unknown actor stole a backpack containing the security guard's person property. The business was closed for the evening, so security camera footage was not available.
10. On 08/26/25, at 10:10 a.m., Milwaukee Police received a Subject with Weapon complaint. An employee called regarding a disorderly subject who refused to leave when asked and started to throw merchandise onto the ground. Upon officers' arrival the subject was gone. Security camera footage was available of the incident.
11. On 09/06/25, at 10:27 p.m., Milwaukee Police received a Subject with Weapon complaint. The caller was no longer on scene, and the subject with a gun was identified as a security guard.
12. On 09/25/25, at 6:21 p.m., officers were dispatched to a Threat complaint. A security guard reported a statement made by a formal employee they believed to be a threat.
13. On 10/01/25, at 10:47 p.m., officers were dispatched to a Subject with Weapon complaint. An employee told a customer who was upset to calm down and not to act like a "mental

person". That customer responded by damaging merchandise and arguing with employees. The customer was gone prior to officers' arrival.

14. On 10/10/25, at 6:25 p.m., officers were dispatched to a Threat complaint. Two subjects in the business complained about the prices. Both subjects left, one came back in and threaten to "steal everything in this bitch". Both subjects were gone prior to officer's arrival.
15. On 12/05/25, at 5:36 p.m., officers were dispatched to Battery complaint. A security guard requested that two juveniles be removed after becoming boisterous. The juveniles complied with officers' request. While on scene the manager showed officers security video of an unknown subject attempting to steal items who was escorted out of the business. The manager stated the business license is pending due to numerous police calls for service. A check of the Filling license showed an expiration date of 12/29/23.
16. On 12/13/25, at 11:29 p.m., officers were dispatched to a Subject with Weapon complaint. An anonymous caller reported a subject with a rifle. The subject was identified as a security guard.
17. On 12/30/25, at 5:05 p.m., officers were dispatched to a Trouble with Subject complaint. The caller reported a panhandler on the property refusing to leave. The caller and panhandler were gone prior to officers' arrival.
18. On 01/08/26, at 10:49 P.m., officers were dispatched to a Theft complaint. A subject attempted to walk out of the business without paying for a tobacco product but was stopped by a security guard. The subject refused to pay or return the item. The subject was issued citations for retail theft and Trespass after refusing to leave when requested.

This report is written by PO Justin YOUNG, assigned to District 3, Late Shift, SQUAD 3330.

On Sunday, January 12th, 2025, at 4:37 AM, PO Adriana GALVAN and I was dispatched to 1202 W Highland AV (BP Gas Station) for a Subject with a Weapon call for service.

Upon our arrival I observed the security officer later identified as Alexander R. MANNAN (B/M, 11/09/1999) sitting inside of his vehicle. MANNAN stated that he was working security for the BP Gas Station when he observed a white SUV coming into the parking lot and was near pump 2. MANNAN stated that the white SUV began backing up toward his vehicle at which point he ran out of the store and approached the white SUV with his black rifle around his neck. MANNAN told the driver of the white SUV, he told her to drive careful. MANNAN stated to officers initially that he did not point his firearm at the driver.

PO GALVAN and I spoke to the initial caller identified via Wisconsin Driver's license as Molly A. DONLEY (F/W, 11/15/1977) who stated that MANNAN pointed his black rifle at her and her passenger as she was driving.

I reviewed video surveillance footage. The footage showed which depicted the following:

2:59 AM- DONLEY's white 4 door SUV arrives to the gas station from entrance on W Highland Av and begins to pull in near pump 2. DONLEY's vehicle then begins to reverse toward MANNAN's black Honda Civic.

3:00 AM- MANNAN comes out of the gas station and points his rifle (later to be a BB gun) toward DONLEY's vehicle.

DONLEY stays in the gas station lot till about 4 AM.

MANNAN was taken into custody at approximately 5:27am and conveyed to District Three for booking and processing. While taking MANNAN into custody, officers retrieved the rifle from MANNAN which was revealed as a facsimile weapon (black BB gun that resembled a rifle from afar).

MANNAN's property is as follows:

- One Black BB Rifle with flashlight attached BB magazine filled with a large amount of BB's. This firearm was taken for evidentiary value and placed under MPD INV#25001111. This firearm was not reported stolen.
- One black Ruger LC9 firearm with magazine, semi-automatic pistol, (Serial#32462033) (Gun Tag 109335). This firearm was taken for safe keeping and placed under MPD INV#25001112. This firearm was not reported stolen.
- One black magazine. This item was taken for safe keeping and placed under MPD INV#25001112.
- Thirteen assorted 9mm cartridges, previously loaded in both magazines and one in the chamber of the black Ruger LC9. This item was taken for safe keeping and placed under MPD INV#25001112.
- Three cans of pepper spray. This item was taken for safe keeping and placed under MPD INV#25001112.
- One Winchester knife with brown handle. This item was taken for safe keeping and placed under MPD INV#25001112.
