Dear Council Members:


Enclosed please find a resolution authorizing the cancellation of a subrogation claim against Julie Blossmore.

Ms. Blossmore filed a personal injury lawsuit against Patrick Griffin and his insurer, Allstate Insurance Company, for injuries suffered in an automobile collision. The City has a subrogation claim in this litigation with respect to medical payments on Ms. Blossmore's behalf under the City's Basic Health Plan, administered by Wisconsin Physicians Service Insurance Corporation (WPS).

As noted in the enclosed letters from WPS, recovery of the policy limit from Allstate Insurance Company would dismiss Allstate from the suit; however, the City may be able to recover additional monies once the issues relating to underinsured motorist benefits have been resolved. We recommend adoption of this resolution.
