Mollie Place, the undersigned Claimant, hereby presents this Claim for Damages against the City of Milwaukee for the sum of TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000.00).

Ms. Place's claim arises on account of personal injuries and damages she suffered as a result of an accident that occurred on February 10, 2000. On that date at approximately 8:46 a.m., Ms. Place was operating her 1997 Nissan automobile on North 8<sup>th</sup> Street at the intersection of West Center Street in the City of Milwaukee, County of Milwaukee, Wisconsin.

At that time and place Ms. Place was proceeding in a southbound direction in the middle lane on North 8<sup>th</sup> Street. The traffic light in her direction was green when a police squad vehicle driven by Patricia A. Schnell and owned by the City of Milwaukee drove into the intersection against the red light causing Ms. Place's vehicle to collide with the police squad vehicle. The police squad vehicle did not have its emergency siren on.

The collision was caused by the negligent acts and omissions of Patricia A. Schnell and the City of Milwaukee.

As a result of the collision, Mollie Place suffered serious injuries causing her past, present and future pain, suffering and disability. Her injuries include a fracture of the right distal ulna and a synostosis in the distal ulna and radius, which has produced a permanent restriction of forearm rotation. In addition, she suffered a rotator cuff tear of one shoulder and may have suffered a rotator cuff tear on the previously injured other shoulder.

Mollie Place's damages of \$250,000.00 are itemized as follows:

1.	Property damage-auto (Allstate subrogation)	\$6,684.87
2.	Medical expenses (Allstate subrogation)	\$2,000.00
3.	Medical expenses for Dr. Harvey Wichman	\$1,225.00
4.	Past medical expenses for MRI Scans	\$1,000.00
5.	Future hospital and surgical fee	\$10,000.00
6.	Pain, suffering and disability (past and future)	\$238,525.43
	Total:	\$250,000.00

Satisfaction of damages of injuries sustained by Mollie Place are claimed against the City of Milwaukee and Patricia A. Schnell.
