Notice is hereby given that an ordinance (passage of which is now pending) was introduced at the November 14, 2006 meeting of the Milwaukee Common Council, the essence of which is as fallow.

Substitute ordinance relating to the change in zoning from Local Business to General Planned Development, on land located on the North Side of West Center Street and West of North 25th Street, in the 7th Aldermanic District.

The Mayor and Common Council of the City of Milwaukee ("Common Council"), do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances ("Code") a new section to read as follows: new section to read as follows:

Section 295-907(2)(a).0028. Section 295-907(2)(a).0028.

(1) In accordance with the provisions of Section 295-907(2) of the Code relating to the procedures and establishment of planned development districts, the Common Council approves the subject General Planned Development, a copy of which is attached to this Common Council File as Exhibit A which is on file in the office of the City Clerk

and made a part as though fully set forth herein.

(2) The zoning map is amended to change the zoning for the area described and bounded by the zoning line within West Center Street, the centerline of North 25th Street, a line 133 feet North and parallel to the north line of West Center Street and Street West Center Street and a line 88 feet West and parallel to the west line of North 25th Street from Local Business (LB2) to General Planned Development

(3) The requirements set forth in said general plan attached to this Common Council File as Exhibit A, constitute the zoning regulations for the area con-tained in such planned development dis-trict described, provided further, that the effect of the approval of such general plan is that such plan shall limit and control construction, location, use and operation of all land and structures included within the general plan to all conditions and limitations set forth in such general plan.

Part 2. Any persons, firm, company or corporation owning, controlling, or managing any building or premises wherein or whereon there shall be placed or there exists anything in viola-tion of the terms of this ordinance; or who shall build contrary to the plans or specifications submitted to and approved by the Commissioner of the De-partment of City Development, or any person, firm, company or corporation who shall omit, neglect or refuse to do any act required in this ordinance shall

be subject to the penalties provided in Section 200-19 of the Code.

Part 3. In accordance with the provisions of Section 295-907(2) of the Code, the City Clerk shall transmit a certified copy of the action taken by the Common Council to the Department

If any section, subsection, sentence, clause, phrase or portion of this ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct and independent provision, and such holding shall not affect the validity of the remaining portions. The Common Council declares that it would have passed this ordinance and each section, subsection, sentence, clause, phrase or portion irre-spective of the fact that any one or more sections, subsections, sentences, clauses or phrases or other portions be declared void or invalid.
