NOTICE OF CLAIM

PLEASE TAKE NOTICE that Roger and Ilona and Sheldon Stank hereby makes claim against the City of Milwaukee, Stating as follows:

1. That Roger and Ilona and Sheldon Stank are adult residents of the State of Wisconsin, residing in the City and County of Milwaukee at 5511 N. 53rd St. and 8110 W. Bradley Road.

2. That at all times pertinent to this Claim, the Stank's were owners of the building located at 8110 W. Bradley Road.

3. That on January 8, 2002 and January 14, 2002 the City of Milwaukee Police Department, executed questionable search warrant No. 1 - January 8, 2002 and questionable search warrent No. 2 - January 14, 2002.

4. That members of this search team used forced entry to the rear door of this residence, pried open this door (rear) of the residence and caused damage to same, during both instances of search.

5. That members of this search team also used forced entry to the garage door, pried open this garage door of this residence and caused damage to same during both instances of search.

6. That members of this search team also used forced entry to the shed door, pried open this shed door of this residence and caused damage to same during both instances of search.

7. That on January 8, 2002 and January 14, 2002, unknown members (some of which were later identified) of the City of Milwaukee Police Department conducted a search of the residence pursuant to the warrant entering the basement, kitchen, diningroom, livingroom, bedrooms No. 1, No. 2, No. 3, attic, and storage areas of the building as well as the garage storage area of garage and storage shed.

8. That members of this search team pried open and negligently damaged doors leading to back entry, front vestibule and garage and shed, and searched thru negligently, belongings of the Stank's; which were contained through out the house in cabinets, closets, drawers, personal belongings, suitcases, duffle bags, tool boxes, fishing boxes, etc., under furniture, in cartons, boxes, organ, appliances.

9. That members of this search team negligently caused damage to a waterbed by shooting two bullet holes thru it, which also caused flooding of the upper bedroom floor and carpet. Negligently vandalized built in drawers by smashing them upon pulling them out and smashing them to the floor, damaging contents, busting them. Negligently vandalized and caused damage to the walls by shooting big holes in these same walls. Negligently vandalized and caused damage to property and shelves by pulling the shelves off their brackets and smashing property on these shelves to the floor. Negligently vandalized & caused damage to the television that was built into the wall, by prying it out and smashing it to the floor. All the above is just in the upper bedroom.

10. That members of this search team negligently vandalized and caused damage to every room in the house and property by their out right neglect and inconsideration for property. Damage was caused to an organ by smashing & prying off the back. Tools and other items are missing that are not listed on their inventories. (list enclosed) Fishing poles are broken, busted & bent. Mounted fish are broken. Heirlooms broken, antiques broken, and missing. Jewelry missing. Receipts & important papers, documents - evidentiary tape recordings, photographs to mention some, receipts were also taken & missing items were taken by the Milwaukee Police Department as so stated on their inventory.

11. We were given a Milwaukee Police Department Damage Notice Card to file a Claim against the City for damages, by a Police Officer and was told that there was going to be an Internal investigation into and on the shooting.

12. That property not listed on the search warrant was taken, stolen and/or damaged due to the (unlawful) vandalism and negligence of the City of Milwaukee Police Department.


13. That as a result of these actions by the City of Milwaukee Police Department, the Stank's suffered damages as follows:

- a. Stolen property (as listed in Exhibits 1-11) -- \$86,544.95
Accumulated 30-40 years from flea markets, swap meets, rummage & estate sales, auctions, curb sales and ward yards.
- b. Damaged property (as listed in Exhibits 1-11) -- \$13,270.34
- c. Stolen cash -- \$850.00
- d. Mental & emotional anguish resulting in physical disabilities -- \$25,000.00
- e. Loss of items still being calculated.
- f. Punitive damages to be determined by the trier of fact.

TOTAL \$125,665.29

WHEREFORE, Roger and Ilona and Sheldon Stank hereby make claim upon the City of Milwaukee for compensatory damages in the amount of \$125,665.29. (plus uncalculated damages - total not to exceed \$500,000.00)
